When dealing with the word of God in a foreign language, (that is, other than the English language) one must understand *the method* in which God Himself has laid out. The material presented here is to show *that method*, God's method in which His words are to be translated into another language, *from* the King James Bible, and that by **“decree”** mentioned throughout various books in the Old Testament. And to answer your question, No, we are not Calvinists.

Because of the lack of knowledge (Hos. 4:6) in this area of Bible translation there is a very small percentage of missionaries that understand the proper and *only* method of Bible translation, that is, from which source a Bible in a foreign language should be translated. Most of the body of Christ, as of 2019 (at the time of this writing) has gone apostate, and has been slipping and sliding backwards at least since the latter half of the 19<sup>th</sup> century, especially in the area of translating the Bible into a foreign tongue. Having the *right* and only Bible as the ‘bottom line,’ the *basis*, the *standard* and as the *FINAL AUTHORITY* from which to translate the living words of the Living God into another tongue is of most importance. If that is not understood in light of the practice of the Bible itself then, the following things take place –

- 1.) There will be much lost; a loss of spiritual insight, loss of understanding, a loss of connection of parallel words in that translation, which make up doctrine.
- 2.) There will be a lack of blessings upon the translation.
- 3.) There will be a lack of revelation given in the text.
- 4.) There will be an impairment of faith among those who read an impaired translation.
- 5.) Corruption will be found in many (to say the least) of the major doctrines in the Bible.
- 6.) There will be many more divisions in the body of Christ because of the ignorance created by Hebrew and Greek ‘scholars’ since 1611.
- 7.) That means there will be less and less unity in the body of Christ (Eph. 4:3).

Concerning the authority and the power of the King James Bible there are three books in the Old Testament that would explain history, in type prophetic history. That is, the Bible would explain events that would happen from between 1917 A.D. to 2019 (the time of this writing). The books Ezra, Nehemiah and Esther actually typify this particular time period. The Author of the Holy Bible (AV 1611), the Holy Spirit, has laid out an order of the canonical books of the Old Testament in the King James Bible in such a way that this particular order is NOT found in *any* Hebrew Old Testament. You will notice in *any* Hebrew Old Testament the books are laid out completely different. Notice the very last four books in the Hebrew Old Testament are Ezra-Nehemiah (together as one book) as also First and Second Chronicles.

Our main attention will have to do with the book of Esther but we'd like to lay out some foreground. You will notice that the order of books in the Hebrew Old Testament have Esther listed as the 5<sup>th</sup> book before the end before Ezra-Nehemiah and Chronicles. In contrast to the Hebrew Old Testament, the King James Bible has the order differently showing Esther *after* Ezra and Nehemiah and just before Job. Also the book of Esther is the seventeenth book with 22 more books left before the Old Testament ends with **Malachi**; 39 books total. The placement of Esther in this particular order we will further explain.

Now considering another resource, the grossly corrupt LXX (*Septuagint*, A.D. 150-500) does not end with Malachi (as in the King James Bible). The corrupt Russian Synodal 'bible' (like many versions of the Bible in various languages) takes many of its readings from the Egyptian, Alexandrian Septuagint. The Septuagint has an additional seven books that are not canonical. That

shows that the priests of the Russian Orthodox Synod along with many other translating committees did not know what they were doing concerning choosing the source upon which to translate their 'bibles.' The grossly corrupt *Septuagint* (Aleph: Sinaiticus; B: Vaticanus; A: Alexandrinus, etc.) ends with 2 *Maccabees*. See any Catholic "Bible." Therefore, for anyone to translate a Bible using Greek manuscripts, especially from Alexandria, Egypt is a 'traitor to the King.'

The reason why it is necessary to point out that Esther is listed after Chronicles, Ezra, Nehemiah and before Job and Psalms in the King James Bible is because this chronological order of the books of the Bible are placed in an order that shows the course of history. True history proves very hard facts.

The second reason why it is necessary to note the differences of order of the Old Testament books is because in the KJB, the books are laid out in a PRE-TRIBULATION and a PRE-MILLENNIAL fashion. That is also future history. That means that Jesus Christ would come to reign on this earth BEFORE the one-thousand year reign. For in Daniel 2:44 we read, "And in the days of these kings shall the God of heaven set up a kingdom, which shall never be destroyed: and the kingdom shall not be left to other people, *but* it shall break in pieces **and consume all these kingdoms**, (plural) and it shall stand for ever."

The post-millennial heresy (that Jesus Christ will return *at the end* of the one-thousand years) is dispelled by the truth of the Lord Jesus Christ obliterating the world kingdoms (plural) and beginning His earthly kingdom (Isa. 9:6-7; Rev. 11:15).

Take a look at Revelation 11:15, "And the seventh angel sounded; and there were great voices in heaven, saying, The **kingdoms** (plural) of this world are become *the kingdoms* (plural) of our Lord, and of his Christ; and he shall reign for ever and ever.

Notice that in corrupt versions of the Bible (including the corrupt Synodal text) have the word "**kingdom**" in the singular so that you could not make the proper cross-reference. That is a lie! Why? So that their attempt to 'bring in the kingdom' would be exposed and SMASHED by the Coming of the Lord Jesus Christ at the end of the Great Tribulation (context of Rev. 11:15) and literally reign on this earth on the throne of David in Jerusalem in Israel.

We mention all of that to say this; this chronological order of the King James text is ADVANCED REVELATION that the Hebrew Old Testament simply does not have. If that weren't enough, because of the fact that First and Second Samuel are as *one* book in the Hebrew Old Testament along with First and Second Kings, First and Second Chronicles and Ezra-Nehemiah, the number of books totals only 35. But in the King James Bible there are 39 books. If you add the 27 books of the New Testament you have a total of 66 books since the Bible is ONE book as one complete unit. That is as many chapters in the book of Isaiah. Right at the beginning of the 40<sup>th</sup> chapter of Isaiah, verse 3 you find "**The voice of him that crieth in the wilderness...**" You read the very same thing in chapter 3 of Matthew which would be the 40<sup>th</sup> book of the Bible, "**The voice of one crying in the wilderness...**" (v. 3). That is the mark of the Divine Hand of God; sixty six chapters in Isaiah, called the 'little Bible' and God ends the canon with John penning the sixty sixth book of the Bible. Don't you find it rather interesting that there were two rows of 6 loaves of bread on the table of showbread in the tabernacle and temple? (Lev. 24:5, 6). What do you do with that other than just believe it. You can't get that kind of 'coincidence' from the Hebrew Old Testament. That shows internal evidence of the *preeminence* of the Reformation text of the Philadelphian period of the Church Age where you read two times that they kept God's word (Rev. 3:8 and 10). That did not happen during the Ephesian period, during the time of the apostles. As a matter of fact, you read, "**...thou hast left thy first love,**" (Rev. 2:4). So much for the '*originals*' of the first century, which nobody has. You may be asking, "What does that prove?" Well, it proves that you're to go with the Book that has more revelation, and advanced revelation, at that, the 'stamp' of God's approval (Rev. 3:8, 10) when it comes to which foundation do you believe to be the final authority to base a translation upon.

So, trusting Greek manuscripts is out of the question. We've seen that. And now coming from a Hebrew text that is out of the question. We've seen that already but let's continue concerning the advanced revelation in the King James Bible –

There are a couple of instances where the order of the books in the King James Bible Old Testament (pre-tribulation and pre-millennial order) prove that the Authorized Version of the King James Bible is THE absolute infallible word of God *for the whole world*. Notice the order of the books Jeremiah, then Lamentations, followed by Ezekiel. And then, again, by *six books*: 2 Chronicles, Ezra, Nehemiah, Esther, Job, and the Psalms. Again, it must be emphasized that this particular phenomena is NOT the order of the Hebrew Old Testament nor the corrupt Septuagint. Therefore all the modern apostates, the New-Evangelicals, Fundamentalists, who do not accept 2 Timothy 2:15 (to show an advanced revelation concerning the proper order and division of the books of the BIBLE) doctrinally or practically fail to see that the King James Bible is THE ABSOLUTE, INFALLIBLE WORD OF GOD from which to translate and / or correct any other version in not only in the English language but also of any foreign language. Therefore to say that the King James Bible is the pure word of God 'for the English speaking people only' is not completely true. It is better to say that the King James Bible is the absolute final authority for any nation, and for any language from which to judge, correct and or translate from. In short, since the English language has borrowed many words from various nations and tongues it is God's way of 'returning the favor' by giving them the word of God in its purest form, with advanced revelations that will enhance the words of God in a Bible in the language from which the English borrowed words. Seeing that the English language is the seventh major language in history by which the words of God would be 'purified (Psa. 12:6, 7), God would wait 'till *that time* to give His words in their purest form at the right time with the most advantageous language, the international language for the whole world as the absolute standard. That had not taken place before.

If you are not convinced yet, please be patient. There is more to come.

When we locate Ezra-Nehemiah between World War I and World War III (*coming up!*), it is done on the basis of *this order*. Note!

First, in **Second Chronicles** you read about Jerusalem being destroyed. That is a type of what had taken place in A.D. 70 by Titus.

Secondly, **Ezra** follows the book of Second Chronicles. Ezra returns from captivity in Babylon and the Jews are given their land back by a Gentile king to rebuild the temple in Jerusalem. (The temple is still *future*, beyond A.D. 2019). At that time the Jews were persecuted by the Arabs. (Read Ezra and Nehemiah chapters 4-6). That is a type of what occurred again in A.D. 1917 during World War I when an English King, George (and not an African, Egyptian, Alexandrian king of any kind) announced in the Balfour declaration support for the establishment of a "national home for the Jewish people" in Palestine.

That is one of the greatest reasons why a translation of the Bible in a foreign tongue should be based upon the King James Bible and NOT upon any Hebrew or Greek text. We will explain that also a bit later.

Thirdly, **Nehemiah** then follows Ezra where even more Jews return to the land and begin to rebuild the walls. The walls of Jerusalem were rebuilt and economic order was restored. This is a type of what has taken place between 1948 and 1990.

4. Fourthly, **Esther** follows Nehemiah where a GENTILE BRIDE (Esther 1) is replaced by a HEBREW BRIDE (Esther 2-3) since the "times" of the Gentiles "ran out" in 1948, after the Gentiles had been rejecting the Gospel for twenty centuries. This replacement of a Gentile queen by a Jewish queen, pictures the Rapture of the church and the commencement of Daniel's Seventy Weeks (Dan. 9:24-27).

5. Fifthly **Job** is after Esther. Job's name means "One persecuted" (Heb.). What took place in the book of Job happened in the very place where the Jewish remnant will be during the Great Tribulation (Hosea 2:14; Rev. 12:6, 14). Sela, "Petra" is located in Edom (Lam. 4:21; Job 1:1; Deut. 33:2; Hab. 3:3). This will take place sometime *after A.D. 2019* (the time of the writing of this book) doctrinally speaking after the Rapture of the Church.

The *forty-two chapters* in Job (in the ENGLISH text of the ENGLISH AV) just happen to match *forty two months* which are mentioned THREE TIMES in Revelation 11:2, 12:6, and 13:5. This proves the order of the books of the Old Testament in the King James Bible is ADVANCED REVELATION that no other books have including the Orthodox Jewish Old Testament.

If that weren't enough there is a resurrection at the end of the forty-two months in Revelation 20:4, so Job's children are *resurrected* (Job 42:13- 14) after forty-two chapters. And by some strange "coincidence", you read in Job 42:10 "**And the LORD turned the captivity of Job**" which is future history, the healing of Job was and will be as the turning of the nation Israel's "**captivity.**" (Zeph. 3:20; Jer. 29:14, 32:44). That's why the order of books in the King James Bible Old Testament is ADVANCED REVELATION that no Hebrew text or any Septuagint text could produce.

In order to destroy that *advanced revelation by the Holy Spirit* made and preserved in the *King James* text, the Synod corrupted the reading in Job 42:10 so that you could not get the revelation. "**Woe unto you, lawyers! for ye have taken away the key of knowledge:**" (Lk. 11:52). The Synodal text, along with all your modern bibles are designed to break the chain references (Scripture with Scripture, 1 Cor. 2:13, "*sola Scriptura*": Luther) so you would LOSE your understanding of "**the holy scriptures**" (Rom. 1:2) thus losing inspiration, "*But there is a spirit in man: and the inspiration of the Almighty giveth them UNDERSTANDING.*"

Since the modern versions along with the Russian Synodal bible are a mix of Church "tradition," and "philosophy" (Col. 2:8), the pagan Synod accomplished its purpose, to combine truth with corrupt readings. The western branch of the Whore of Revelation 17 and 18 would be the Roman Catholic Church doing the corrupting.

So then, after the book of Job, (in the King James Bible), after forty-two chapters, (i.e., forty months, in Revelation) what do you suppose happens at the END of Job's forty-two months (chapters)? You read about the Lord Jesus Christ REIGNING on this earth in Psalms.

Yet have I set my king upon my holy hill of Zion.

I will declare the decree: the LORD hath said unto me, Thou *art* my Son; this day have I begotten thee.

Ask of me, and I shall give *thee* the heathen *for* thine inheritance, and the uttermost parts of the earth *for* thy possession.

Thou shalt break them with a rod of iron; thou shalt dash them in pieces like a potter's vessel.

Be wise now therefore, O ye kings: be instructed, ye judges of the earth. (Psa. 2:6-10)

In Revelation 20:1-6 you read about the dragon, that old serpent...bound for "a thousand years so that he would no longer deceive the nations, till the thousand years should be fulfilled: **and after that he must be loosed a little season... But the rest of the dead lived not again until the thousand years were finished. This is the first resurrection.**

**Blessed and holy is he that hath part in the first resurrection: on such the second death hath no power, but they shall be priests of God and of Christ, and shall reign with him a thousand years"** (Rev. 20:1-6).

This is the premillennial order – after Job (Tribulation) then Psalms – Jesus Christ reigns for 1000 years.

Enter the book of Esther

The book of Esther is a rather interesting book because we find the word “**decree**” mentioned 13 times out of the 57 in the entire Bible.

It is only second in number of times mentioned, two less times than in the book of Daniel.

A Gentile King and his counterpart

This is rather important because as we have learned that as **Cyrus, the Gentile King** gave the decree for the Jews to return back to their homeland, it was the **Gentile King of England, George V** that issued the **Belfour Declaration (1917)** which pledged the British Monarchy to the establishment of a national home for the Jewish people in Palestine.

These are historical FACTS that cannot be denied. If that weren't enough Daniel 7:4 establishes the fact that Persia is a type of England with the emblem of a lion with wings.

Since Babylon was the ruling kingdom at the time of the vision in Daniel 7, it does not figure in the interpretation because these kingdoms come *after* Babylon (7:17). The lion represents Media-Persia before Calvary, but after Calvary it represents *England*. *Both nations were the only nations in history that mandated the return of the Jews to Palestine* (2 Chron. 36:22-24).

Not only that. We find also in the book of Esther that Ahasuerus, “**reigned, from India even unto Ethiopia, over an hundred and seven and twenty provinces**” (Esth. 1:1).

#### **An international Kingdom**

We will look into that a bit later. But for now suffice it to say that the kingdom of Ahasuerus was ‘international,’ that is, it was over various countries; Egypt, Asia Minor (Turkey) all the way east to India covering various parts of three different continents, which is covering a vast amount of territory for just one king.

### **The Seven Steps and Various aspects of a Decree of a King**

A study in the book of Esther and other books of the Bible show the importance and parallel events with the King James Bible to prove the METHOD and APPROACH to a Bible translation in another language since the publication of the King James Bible (1611) regardless of what all the Hebrew and Greek scholars would have you to believe.

Now as we study this matter of the words of a decree from a king we will break it down in steps.

#### Step no. 1

Step number one consists of the matter that there has to be a *basis of power and authority*.

Notice in 2 Chronicles 36:22, 23 when king Cyrus like any other king spoke he spoke having power and authority –



Now in the first year of Cyrus king of Persia, that the word of the LORD *spoken* by the mouth of Jeremiah might be accomplished, **the LORD stirred up the spirit of Cyrus king of Persia, that he made a proclamation throughout all his kingdom, and put it also in writing, saying,**

Thus saith Cyrus king of Persia, All the kingdoms of the earth hath the LORD God of heaven given me; and he hath charged me to build him an house in Jerusalem, which *is* in Judah. Who *is there* among you of all his people? The LORD his God *be* with him, and let him go up.

Now wouldn't you say that the king spoke with power? Was that not enough that what he said took place HISTORICALLY? The Bible is not only a religious Book; it is a historical book giving you the facts of what took place.

The king had a kingdom. That is power. He reigned over three different continents. That is power. As a matter of fact it was **"the LORD"** that **"stirred up the spirit of Cyrus king of Persia, that he made a proclamation throughout all his kingdom..."** That is POWER! The LORD gave him that power! You see, the source of His power came from God. THAT IS POWER!

For a translation to be 'effective' it must have maximum power. It's source must have power and authority. When dealing with this matter of *final authority* the first thing that has to be considered is, who is the king? Who is the boss? Or better yet who has the power and AUTHORITY to speak with authority and to fulfill what has been spoken so that his subjects will fulfill what the king expects? We will answer that question rather simply but first let us illustrate this all important issue of authority.

When children play 'king of the mountain' one stands on the top and the others try to get him off the top of the mountain so that another can stand on the top and be 'king.'

To illustrate the issue further, when Jesus Christ preached His very first sermon, the sermon on the MOUNT, we read in Matthew 7:28 and 29 –

“And it came to pass, when Jesus had ended these sayings, the people were astonished at his doctrine:

For he taught them as **ONE HAVING AUTHORITY**, and not as the scribes.”

So then we can make the conclusion after the very first sermon of Jesus Christ Who preached on the **"MOUNT"** that He is the *'king of the MOUNTAIN.'*

One day Jesus taught in the temple and what do you think the scribes and Pharisees thought about that? Well, their very first question had to do with AUTHORITY –

“And it came to pass, *that* on one of those days, as he taught the people in the temple, and preached the gospel, the **chief priests** and the **scribes** came upon *him* with the elders,

And spake unto him, saying, Tell us, by what **AUTHORITY** doest thou these things? or who is he that gave thee this **AUTHORITY?"** (Lk. 20:1, 2).

Of course the chief priests and the scribes couldn't figure Jesus out. They were too stupid and blind. Jesus answered their question with a question concerning the baptism of John (Lk. 20:4) and the chief priests and the scribes were dumbfounded and couldn't answer (v. 7). So Jesus Christ would not answer their question about His authority. Then Jesus went on and told a parable about a certain man that planted a vineyard and set it to husbandmen. The man sent servants to the vineyard but the husbandmen beat and killed those sent (Lk. 20:10-19). When He finished His sermon He let them 'have it.' He went on to explain that the Lord of the vineyard would send his own son. That was Jesus Christ. But the council would have none of Jesus Christ that's why Jesus said, **"But the stone which the builders rejected, the same is become the head of the corner?"**

“Whosoever shall fall upon that stone shall be broken; but on whomsoever it shall fall, **it will grind him to powder.**” (Lk. 20:18)

So since the chief priests couldn’t handle Jesus’ power and authority, this is what you get – “And the chief priests and the scribes the same hour sought to lay hands on him; and they feared the people: for they perceived that he had spoken this parable against them.” (v. 19)

Now watch this –

“And they watched *him*, and sent forth spies, which should feign themselves just men, that **they might take hold of his words**, that so they might deliver him unto the **power and AUTHORITY** of the governor.” (v. 20)

You see, there was another *authority*. Somebody was out to catch Jesus in his words. As a matter of fact they had to lie and create a situation that would make Jesus Christ a liar. But they couldn’t so Jesus was *falsely accused*.

*APPLICATION:* There is a competitor, the Devil who comes and says, “**Yea, hath God said...**” (Gen. 3:1). That came from another authority. Let’s get his history –

“How art thou fallen from heaven, O Lucifer, son of the morning! *how* art thou cut down to the ground, which didst weaken the nations!

For thou hast said in thine heart, I will ascend into heaven, I will exalt **MY THRONE** above the stars of God: I will sit also upon the **MOUNT** of the congregation, in the sides of the north:” (Isa. 14:13, 14).

You see, Lucifer wants to be ‘king of the mountain’ but since he was put down by God he is still out to pervert the proper picture of WHO has all the power and AUTHORITY!

*APPLICATION:* So the King James Bible will have its competition, i.e., other bibles that claim to have ‘authority’ and those that choose to critique the King James text.

So then we are dealing with a Kingdom and a King who sat on a THRONE. Look at what the book of Esther has to say about these things 1:2, 4, 14, 2:3, 5, 8; 4:14; 5:3, 6, 7:2; 9:30.

“Now it came to pass in the days of Ahasuerus, (this *is* Ahasuerus which reigned, from India even unto Ethiopia, **over an hundred and seven and twenty provinces:**)

*That* in those days, when the king Ahasuerus **sat on the throne of his kingdom**, which *was* in Shushan the palace,” (Esth. 1:1-2). (See also verses 1:4, 14; 2:3, 5, 8; 4:14; 5:3, 6; 7:2; 9:30).

You would have to admit that a king that is over **one hundred and seven and twenty** provinces, from India even unto Ethiopia is no small sphere of ‘influence.’ He sat on his throne and what the King says, goes! *That is POWER AND AUTHORITY!*

*APPLICATION:* Since it was a King of England that had the power and authority to issue the Belfour Declaration, so it was a Gentile King, James that issued the authority for the King James Bible.

Not surprisingly, many of *the premier* vernacular Bibles, were produced under the “authority” of kings, such as:

1. Alfred the Great of England (c. 899)
2. King Alfonso of Spain (from vernacular French into Spanish around 1223)

3. King Jean II of France (1333)
4. King Francis I and son Henry (Stephanus text of 1550)
5. King Christian III of Denmark (c. 1550)
6. **King James I (Authorized Version 1611)**

(From 'In Awe of Thy Word' by Gail Riplinger, p. 546)

In short, if your Bible (that's the Old and New Testaments together) doesn't come from a King, then there is going to be a major loss of power in it!

**“Where the word of a king is, there is power: and who may say unto him, What doest thou?”**

#### The ““What doest thou?” Society”

Unfortunately, there are a great number of men that have asked the question, “**What doest thou?**” It's the same group of men of the Alexandrian Cult mentality. It is the same men that belong to the Satanic “**Yea, hath God said,**” Society.” These are men like **Origen** of Alexandria (c. 184 – c. 253), Jerome (347 – 420), Augustine (354 – 430 AD), Brooke Foss Westcott (1825–1901) and Fenton John Anthony Hort (1828–1892), all the Bible translation committees since 1901 that produced the American Standard Bible in America to Fundamentalists that hold to a dual authority of a Textus Receptus text *AND* the King James Bible (Jack Schaap, Donald Waite, James White, Steve Anderson, etc.) to Yuro Popchenko, a 'TR' man from Ukraine.

So when you are dealing with the King James Bible, you are also dealing with the “**King of Jacob**” (Isa. 41:21), for it was God Himself that put James the King of England on the throne. That is power and authority!

You may have noticed that when any man preaches from a 'bible' that has any readings from Alexandria, no matter what language you hear that sermon in, that is, if you understand another language you notice there is a loss of power. Bar none!

This author has heard sermons in three different languages. And when a preacher preaches and if his text has any readings that do not line up with the King James text, it is noticeable that there is a loss of power in the preacher himself, in the preaching and among the listeners. It all 'goes over' like a 'lead balloon.'

We are yet to touch upon those that adhere to a Textus Receptus slant by going to 'the Greek' for a 'nugget' of revelation. That is to 'pull the wool over your eyes.' We will get into that also for on the mission field it is the same ole song and dance – clashes of spirit. When one claims that a translation should come from the Textus Receptus from which the King James was translated and others claim that a translation should be based upon the King James Bible into a foreign tongue you have a clash of spirits. The question then would be, which way are you to go. To solve that problem is solved in the King James Bible.

#### Step no. 2

*The king makes certain decrees that become law.* You find that in Ezra 1:1 –

“Now in the first year of Cyrus king of Persia, that the word of the LORD by the mouth of Jeremiah might be fulfilled, the LORD stirred up the spirit of Cyrus king of Persia, that he made a proclamation **throughout all his kingdom, and put it also in writing**, saying...”

“If it please the king, let there go a royal commandment from him, and let it be written among the laws of the Persians and the Medes, that it **be not altered,**” (Ezra 1:1).

So, here we find the very steps concerning the METHOD and APPROACH for translating the Bible into another language. First of all the translation must come from the 'original' words of a

KING. Well, it was King James that authorized the translation after his name and “**Where the word of a king is, there is power: and who may say unto him, What doest thou?**” (Eccl.8:4). That is the parallel of a decree of a king as in Ezra, and Nehemiah. It is NOT by accident that the God of history waited until the international language of English and the world power, (England) would rise to the top. Only a blind fool cannot see the hand of God in the history of England and her power around the world. The God of the Bible is the God of history. Not only that, God would wait until the Latin and German languages had ‘their’ day. The Lord would not use the Latin language to be THE language from which all other Bibles are to be translated for the Latin language is the main language for the Roman Catholic Church (the WHORE of Revelation 17 and 18). Also, although Martin Luther’s translation **Heilige Schrift**, is what God used to shake Europe, but it still was not the seventh (number of perfection), nor the mark of perfection of a translation for it also has readings in it that agree with faulty reading in later versions. Not only that, the country of Germany is a land-locked country with very little access to the Seas. It wasn’t until after the Gutenberg press was invented, it wasn’t until the Queen of the Seas (England) rose to world power that the King, James sat on the throne where the most prolific of Biblical scholars, forty-eight to fifty four of them sat down and went to work to produce the greatest work of literature in the history of the world, let alone the Church. Such an event had never taken place in the history of man and never has since then. There has never been before or after the translation of the King James Bible an event like that to that extent, where under the authority and power of a king, a saved king at that, where a world power, (as it happened with England during the Philadelphian church period of Church History (Rev. 3:7-13), that translators, (let alone 54 of them under King James) went to work to translate the Bible in any other language. That is history that simply cannot be contended.

The decree of the King (James) went out!

### Step no. 3

*The decree is committed to writing.*

“For he sent letters into all the king’s provinces, into every province **according to the WRITING thereof**, and to every people after their language, that every man should bear rule in his own house, and that *it* should be published according to the language of every people” (1:22).

See the following verses for further confirmation (2:23, 3:9, 12, 14; 4; 8; 6:2; 8:5, 8, 9, 13; 9:23, 27, 32; 10:2).

Notice how this principle is mentioned also in the book of Daniel 3:29 “Therefore I make a decree, That **every people, nation, and language**, which speak any thing amiss against the God of Shadrach, Meshach, and Abednego, shall be cut in pieces, and their houses shall be made a dunghill: because there is no other God that can deliver after this sort.”

Again we make the following observations –

1. What the king says is final. That is what you call FINAL AUTHORITY!  
That is exactly what the King James Bible is – FINAL AUTHORITY!

In Daniel 6:7 we read that a “royal statue was established and that the king Darius would make a “firm decree.” In verse 8 we read, “Now, O king, establish the decree, and sign the writing, **that it be not changed**, according to the law of the Medes and Persians, which **altereth not**.”

2. It is committed to writing. (Dan. 6:9)

Before that decree from a king is translated there is one major detail that must be established, that the decree cannot be changed. Look at Daniel 6:8

“Now, O king, establish the decree, and sign the writing, **that it be not changed**, according to the law of the Medes and Persians, **which altereth not**.”

That is confirmed in verse 12, “Then they came near, and spake before the king concerning the **king’s decree**; Hast **thou not signed a decree**, that every man that shall ask *a petition* of any God or man within thirty days, save of thee, O king, shall be cast into the den of lions? The king answered and said, **The thing is true, according to the law of the Medes and Persians, which altereth not**.”

Notice here that once a decree had been committed to writing that others can go to, to check it out and see if it be TRUE!

*APPLICATION:* The King James Bible has been AUTHORIZED by the King and has ESTABLISHED KINGDOMS AND WORLD POWERS. The false ‘bibles’ have produced apostasy and apathy.

So in type, you have a king, Darius – type of God the Father who ministers by the law of a decree (and not heretical ‘Decrees of God’ of John Calvin) that once committed to writing, that that decree *cannot change*. Just to make sure that people get the point, the Holy Spirit repeats that in Daniel 6:15 – “Then these men assembled unto the king, and said unto the king, Know, O king, that the law of the Medes and Persians *is*, **That no decree nor statute which the king establisheth may be changed**.”

Now isn’t that something that we read that same type of thing in Malachi 3:6, “**For I am the LORD, I CHANGE NOT; therefore ye sons of Jacob are not consumed**.” And just as the Lord has preserved his people, God has preserved His word, word perfect (Psa. 12:6) in the King James Bible.

On the contrary, men *fail* (Psa. 12:1) and *change*. There are a great number of apostate ‘Christians’ today to *fail* to see how God blessed England with a King James Bible, blessed America with the King James Bible and many other countries, Ireland, Wales, Scotland, etc.

It wasn’t until people began to CHANGE, that their ‘bible’ also CHANGED! Strange isn’t it? Now you have over 350 ‘bibles’ in the English language, multiple ‘bibles’ in other languages that all say something different. THEY CHANGED! For in Romans 1: you read –

“Who **CHANGED the truth of God into a lie**, and worshipped and served the creature more than the Creator, who is blessed for ever. Amen” (Rom. 1:25).

All of the modern versions CHANGED the word “CHANGED” to “**exchanged**.” Now that is how slick Satan is and those that are apt to CHANGE the words of a king. They are rebels. God’s word CANNOT change for He is the keeper of His words (Psa. 12:6, 7). That means that all of the corrupt ‘bibles’ are the fruit of corrupt minds (2 Cor. 11:1-3) and accepted by those that are also

given to change; the whole bunch of them from the modern, non-denominational far left churches; Joel Olsteen, Carl Lentz, Rick Warren, David Jeremiah, to more moderate, apostate, non-denominational churches; John MacArthur, Charles Stanley, Moody Bible Institute, Bob Jones University. The hyper-fundamentalist crowds have been given to change also: Jack Hyles, John R. Rice, Jack Schaap, Lee Roberson, etc. These men ‘believed’ the King James Bible but their ‘out’ was either ‘the originals’ are or were the word of God or that ‘no translation could be better than the Hebrew and Greek from which the King James Bible came. Later on in his ministry eventually Jack Hyles made a stand solely for the King James Bible.

Then there is another ‘branch’ of the Hyper-Fundamentalists and that is the ‘super zealot’ hyper-fundamentalists led by Stevie ‘wander’ Anderson that are given to CHANGE. He cannot handle the Book when it comes to 2 Timothy 2:15 just like most of the Fundamentalists. The more ‘serious’ they are trying to expound the scriptures the funnier they become. Stevie ‘wander’ Anderson has failed to see the superiority of the King James Bible and the advanced revelations that the Hebrew and Greek manuscripts simply do not have. What makes things funnier is this kid tries to refute the Biblical position. When we say Biblical, we mean one book and no other – the King James Bible. He is childish in his approach. When put to the test concerning comparing the advanced revelations to a Hebrew Old Testament or a Greek New Testament, (which he is not about to do) the ‘ole’ black back 66 simply chews him up and spits him out.

The Biblical position of Biblical faith is – the King James Bible is THE word of God, and not the Hebrew and Greek from which it came. Stevie ‘wander’ Anderson has been given to change in that his dual authority position (Hebrew/Greek-English), which in reality is Catholic, causes his own blindness concerning FINAL AUTHORITY. You’ve got to choose. Either you are going to ‘go’ with the Hebrew and Greek manuscripts or the King’s English. If you choose the Hebrew and Greek THEN PREACH FROM *THEM*. Don’t be piddlin’ around with the King James Bible. Preach from the Hebrew and Greek. If you are settled with the King James Bible then DON’T REFER TO SOME GREEK MANUSCRIPTS when there are dozens of them and they all say something different and they cannot hold a match to the ‘roaring lion’ of the AUTHORITY of the KING James Bible of the Philadelphia period.

[For further information concerning the Advanced Revelations of the King James Bible please see our book ‘**ADVANCED REVELATIONS In THE KING JAMES BIBLE That No Hebrew or Greek Text Has.**’]

Concerning the Philadelphian period of Church History, you never hear a rebuke (Rev. 3:7-13). The Greek came from the period that left its first love (Rev. 2:4). No king sat on a throne in Greece at the time of the writings of the New Testament were written in koine Greek. So you have to scratch that option out for the ‘final authority.’ The international language today is English, not Greek. The proofs of the King James Bible as the “king of the mountain’ are so innumerable it is just pitiful that many good men in the body of Christ have been deceived into thinking that just one book, one standard, as Jesus Christ is One Standard, couldn’t be the final authority for the whole world. Although many may ‘say’ that, nonetheless they speak with a forked tongue and are unstable and ‘Catholic’ at heart. We cannot go into *all* the proofs; internal, external, historical, geographical, etc. concerning the AUTHORITY of the King James Bible, nor the proofs of the “changed” position of all of the above mentioned groups but we are just touching on all of these aspects so as to ‘wet your appetite.’ Our main objective is to show the principle of translating THE translation of all translations, the King James Bible into other languages. The reason for that is –

1.) “**Unity of the Spirit**” (Eph. 4:3) in the body of Christ by “**One Lord**” and “**one faith**” (Eph. 4:5).

2.) Preserving ‘the kings’ words into other languages from One King, King Jesus Who has preserved those words and authorized and sanctioned those words just as King James in 1611 A.D.

3.) To see the parallel between King Jesus using a man, King James – “James” is the English word of “Jacob.” Not only that, an entire Epistle of the Bible is written from James.

“Produce your cause, saith the LORD; bring forth your strong *reasons*, saith the **King of Jacob**,” (Isa. 41:21).

The King of Jacob is Jesus Christ, or God the Father in the Old Testament, and not only that. Although God identified Himself as the “**King of Jacob**” He rules (present tense) over all the nations right now!

“This matter *is by the decree* of the watchers, and the demand by the word of the holy ones: to the intent that **the living may know** that the **most High ruleth in the kingdom of men**, and giveth it to whomsoever he will, and setteth up over it the basest of men.” (Dan. 4:25).

“The LORD hath prepared his throne in the heavens; **and his kingdom ruleth over all**” (Psa. 103:19).

This verse is talking about God’s kingship and exercising AUTHORITY over the earthly political kingdoms of this world, just as God did by giving King James the authority to rule. And to represent God’s rule and power, He, the Lord allowed for King James (Jacob) to rule over a kingdom and for a translation of God’s words to spread world-wide.

Therefore there can be only One Book that properly represents Him that can rule over all the nations and it is associated with a King who sat on a throne from which we get our standard of time, temperature and geographical location – the King James Bible. It was God that gave ENGLAND that opportunity through which His eternal “**words**” would go throughout the whole world in one “**word**” – the King James Bible.

Now let’s get back to our subject at hand. The law of the Medes and Persians *is*, **That no decree nor statute which the king establisheth may be changed.**” Since the Gentile king (Cyrus) is a type of the British King letting the Jews to back to their homeland, you’ve got to see the connection to fully understand how, in God’s providence England would play a major role not only in Church History but in World History. God’s book in the international language would go into ALL THE WORLD. And His book hasn’t been given to change!

We read in Psalm 149:6, “**Let the high praises of God be in their mouth, and a twoedged sword in their hand.**”

The sword is clearly the written word of God (Eph. 6:17). The *decrees of God* (not the heretical system of Calvin’s ‘decrees’) are limited to the written word, which becomes the *Rules of Court* for the Judge (John 12:48). “**He that rejecteth me, and receiveth not my words, hath one that judgeth him: the word that I have spoken, the same shall judge him in the last day.**”

God will not contradict the *written words of God*. Just as the Lord has ONE STANDARD (Jesus Christ) by which He is going to judge all people (Acts 17:31), so then He also has ONE STANDARD by which all other versions should submit to. Just as every true believer, that is, those that are “**in Christ**,” are to follow the Lord Jesus Christ and allow the Holy Spirit to work in him (Col. 1:29; 1 Thess. 2:13) that Jesus Christ would manifest Himself, so also any and ALL translations are to submit to One Book. Since there can be only One reigning King whose words are true and pure, so also His words in the form of a Book – The King James Bible, are to have sole precedence. Just as the Gentile Kings gave decrees as we have been seeing in our study of final authority, and their words were ‘final’ in their kingdom, in all the providences, so must also there be

ONE FINAL WORD in God's kingdom. There can be only ONE STANDARD BY WHICH ALL OTHER TRANSLATIONS MUST SUBMIT.

### **The Providence of God and the Authorized Version of the King James Bible**

In the international language of English, God in his providence has preserved His word in the Authorized King James Version of 1611. This is a true pure text having been purified seven times in a furnace of earth. The number seven according to the Bible is the number of perfection and the English language is the seventh. The other six being;

**1. Hebrew** - spread by the world power Israel. God saw fit to give His words to only ONE nation – Israel. The Hebrew language was not a language that ‘borrowed’ from other languages ut it would be the language from which other translations would come for others in different countries to know what God said. More revelation was yet to come – the New Testament.

**2. Syrian** - spread by the Syrians.

**3. Aramaic** – Language spoken in Ezra 4:8-6:18 is in Syriac (Aramaic). Also Daniel 2:4-8:1 was written in Syriac, (Aramaic). That means that a TRANSLATION would be necessary for that to be in the Hebrew tongue.

**4. Greek** – Greece was a world power under Alexander. Although the Greek language was the language in which the New Testament was written, the apostle Paul reminds us that scriptures were being corrupted (2 Cor. 2:17). It is the Church of Ephesus that “**left [it’s] first love**” (Rev. 2:4). God would still have yet for his word, (all 66 books) in “**a more excellent way,**” (1 Cor. 12:31) purified SEVEN times whereas the Greek language would have only been the FOURTH major language in the history of man.

**5. Latin** – This language the Lord would not have to be the dominant language for all the world as the English language would. It is remarkable that in the English language there are only five letters in the word ‘Latin.’ Let’s not also forget that the Roman Catholic Church ‘ruled’ during the Dark Ages and its main language was Latin. That would hardly be the dominant language for the world internationally and also for the Latin text to be a *more perfect* text from which all other languages would translate. God was yet to show forth the more perfect text.

**6. German** – Luther’s Bible was the basis of the Reformation. Although Martin Luther was used of God in a tremendous way, and although his translation was used in a mighty way, God was yet to perfect His work and word with a language that would far surpass the German language and Luther’s text.

**7. English** - Look at Psalm 12:6. It says “**PURIFIED SEVEN TIMES.**”

In the Bible the Lord works many ways with a numbering system of “seven.” For the very first time in the entire Bible the word “seven” shows up where God ended his work and rested,

“And on the **seventh day God ended his work** which he had made; and **he rested on the seventh day** from all his work which he had made. If that weren’t enough we read in the next verse,

“And **God blessed the SEVENTH day,** and **SANCTIFIED IT:** because that **in it** he had **rested from all his work** which God created and made.”

*APPLICATION:* Just as God sanctified the *seventh* day, He sanctioned the King James Bible for it is based on the *seventh* major language of the world of man’s history and is the result of six other previous English Bibles: Tyndale (1525), Coverdale (1535), Matthews (1537), Great Bible (1539), Geneva Bible (1560) Bishops Bible (1568), and finally the seventh, the King James Bible (1611).



Number *seven* for the most part is the number of perfection in the Bible. In the Bible itself is a certain system of sevens –

1. There are seven days in a week (Gen. 1:2-2:3)
2. There are seven “weeks” of the “feast of weeks” (Exod. 34:22; Lev. 23:9-14).
3. There are seven months or the “seventh month” of the “feast of tabernacles (Lev. 23:1-44).
4. There is the “seven years” which makes of the sabbatic year (Exod. 21:2; Lev. 25:1-7).
5. There are seven of seven years which would be the year of Jubilee (Lev. 25:8-17).
6. There are seven one thousand years before the New Earth is created (Rev. 21-22).
7. There will be seventh “ages” or mentioned as “ages to come” in Ephesians 2:7).

So why would it be hard for a person to think that God would not care enough for His very words to be preserved in the seventh major language for the whole world to know of, translate from and try any and all other translations on this earth? For since the words of God are “...**tried in a FURNACE OF EARTH, purified seven times,**” (Psa. 12:6) then why would it be so difficult for people to believe that God couldn’t preserve His words in the King James Bible in the seventh major language of English for the whole world? It would be difficult for only those that are not honest. They are the hypocrites, liars (Rev.2:2) Nicolaitans (Rev. 2:6, 15), of an Alexandrian mentality who are yet to understand a “**the way of God more perfectly,**” (Acts 18:26), the “scholars” of the “**Yea, hath God said,**” society, whose satanic, fleshly works will be judged at the Judgment Seat of Christ for their ignorance, if they are saved, for “**For the time is come that judgment must begin at the house of God:**” (1 Pet. 4:17).

“**perfect**” and “**more perfect**” “**excellent**” and “**more excellent,**”

Although through the long course of history concerning God’s words being copied out and or translated in their purest form there still would not have been a *completion* of all this until there was the King James Bible for it is based on the *seventh* major language of man’s history. It is a “*more perfect*” translation than that which was previously “perfect.” It is possible for something to be “perfect” and can still be perfected, i.e., ‘improved’ upon. This idea of superlative action or comparison is from the Bible itself. Notice the following verses –

“And he began to speak boldly in the synagogue: whom when Aquila and Priscilla had heard, they took him unto *them*, and expounded unto him **the way of God more perfectly**” (Acts 18:26).

This man, Apollos, was born in Alexandria, (of all places) was *perfect* in what he knew concerning the scriptures but he needed some ‘advanced’ classes of knowledge. So Aquila and Priscilla gave him an ‘advanced theology’ class. Apollos ‘got’ the advanced revelation. You have to ‘move on.’ That is exactly what the Lord did with the English language – He moved on to a more perfect language and Book.

Let’s take another look at this Biblical superlative –

“But Christ being come an high priest of good things to come, by a **GREATER** and **MORE PERFECT** tabernacle, not made with hands, that is to say, not of this building;

**HOW MUCH MORE** shall the blood of Christ, who through the eternal Spirit offered himself without spot to God, purge your **conscience** from dead works to serve the living God?”

(Heb. 9:11, 14)

Notice here that although the tabernacle and the service in the Old Testament tabernacle was *exactly* what God wanted at that time (vss. 9:9; 10:1), there was yet be the tabernacle that would be, “**MORE PERFECT,**” (v. 11).

As there can be some things that are “perfect” and others “more perfect” in comparison, so also are there things mentioned in the Bible that are “excellent” and yet “more excellent,” –

“And knowest *his* will, and approvest the **THINGS THAT ARE MORE EXCELLENT**, being instructed out of the law; (Rom. 2:18).

“But covet earnestly the best gifts: and yet shew I unto you a **MORE EXCELLENT** way” (1 Cor. 12:31)

“Being made so much better than the angels, as he hath by inheritance obtained a **MORE EXCELLENT** name than they,” (Heb. 1:4).

“But now hath he obtained a **MORE EXCELLENT MINISTRY**, by how much also he is the mediator of a better covenant, which was established upon better promises,” (Heb. 8:6).

*APPLICATION:* As there has always been God’s words since their inception, which does not mean that there could not be more revelation as time went on. Also we’ve seen throughout history that although God’s words have been translated even in the original languages, that does not mean that the previous languages were the most advantageous seeing that the SEVENTH language would be THE language, (English) during the height of language, culture, missionary movements, and the period of “brotherly love,” Philadelphian period where, according to the Bible, God’s words were “KEPT,” (Rev. 3:8, 10).

If one would do any simple research as to the fruit of the Philadelphian period it would be easily seen that the two major translations that have done more concerning the salvation of souls, missionary movements, culture, literature, the arts, music, etc. are Luther’s Heilige Schrift and the King James Bible.

With this Biblical approach to superlatives there should be no doubt as to God’s method, timing, language and efforts to make a ‘more perfect’ and / or a ‘more excellent’ text, from the seventh major language in man’s history from a world power that He Himself set up, allowing a King to sit on a throne, for God words to be published around the whole world in various languages. That is THE way it is to be done!

So, let’s review a little and add a bit more information here concerning the King James Bible –

1. It has **AUTHORITY**. A king also has authority. Jesus Christ was a King.
2. It has power. King James had power during his reign. Jesus Christ has power.
3. The Bible speaks of a king that has authority and power and his words cannot be questioned (Ecc.8:4).
4. The king’s reign is a monarchy. That is the same kind of reign that was during Solomon’s time; as also King James and also will be the kind of government in the millennium under the reign of Jesus Christ.

### **GOD IS THE AUTHOR OF NUMEROLOGY**

5. In the Authorized Version the ninth book of the New Testament is Galatians. Unfortunately the Orthodox priests of the Synodal text would not accept the order of the canonized books of the New Testament inspired by the Holy Spirit. (See our chart on the order of the canonized books of the New Testament).
6. The number nine is the number for *fruit bearing* in the Bible. In the ninth book of the New Testament is listed the “**fruit of the Spirit**” (Gal.5:22, 23).
7. Abraham was 99 when he had Isaac.
8. Isaiah 27:9, notice verse NINE, is dealing with the FRUIT of Israel.
9. In the English language the two words ‘King James’ has *nine* letters to it.

10. The Hebrew name for James is Jacob, a Biblical name. God chose a man with a Hebrew name to give the authority for the translators to do their work. At one time in America the most popular name was James. That name is derived from the Hebrew name Jacob. So the Lord waited until 'James' would sit on the throne in England before the King James Bible would be produced and through him that greatest historical event would take place, approximately 50 men would translate the most popular book in the world.
11. In the English language the book of Galatians has nine letters to it.
12.  $1+6+1+1=9$
13. Just as there was approximately 400 silent years after Malachi until the First Coming of Christ to prepare the world with the international language of Greek so there is approximately 400 years after the King James Bible was translated, to prepare the world in the international language of English.
14. Revelation 3:7-13 speaks of the Philadelphian Church which, historically is the time of the Reformation from about 1500 – 1900 A.D. It was the greatest period in the history of the Church of worldwide missions. Some of the greatest missionaries came from England after translation of the King James Bible.

### **Other Factors that Play a Major Role and the Providence of God**

Consider these undeniable facts which can only be attributed to the providence of the God of the King James Bible –

The standard for time is from Greenwich, England. The standard for time in the first century (Greek) when the New Testament was written was not from Greece when the Greek language was the international language. The standard or prime meridian, or 0° longitude is *Greenwich, England*; Greenwich marks the zero point from which longitude is calculated. GMT is sometimes called **Greenwich Meridian Time** because it is measured from the Greenwich Meridian Line at the Royal Observatory in Greenwich. Greenwich is the place from where all time zones are measured and is the average time that the earth takes to rotate from noon-to-noon. It is midday at any place on the surface of the earth when the sun's direct rays pass over the meridian of that particular place. Stars and planets appear to be directly overhead when they are observed passing over the meridian.

1. That means that the standard of the stars is observed by GMT.
2. The standard for languages today is English.
3. The international language is English.
4. The international Bible is the King James Bible by which to judge, try and prove all other translations including Luther's **Heilige Schrift**.

Although the equator was an obvious choice as the prime parallel, being the largest, no one meridian was uniquely qualified as prime. Until a single prime meridian could be agreed upon, each nation was free to choose its own, with the result that many 19th-century maps of the world lacked a standardized grid. The problem was resolved in 1885, when an international prime meridian, passing through London's Greenwich Observatory, was officially adopted by 25

countries, as part of the agreement that established Standard Time. A metallic marker at Greenwich indicates its exact location.

These are FACTS that can be scientifically observable and proven. Any other position is evolutionistic at heart. You can't prove evolution. You CAN prove DE-evolution, i.e., degradation, entropy, the 2nd law of Thermodynamics.

To use any Greek text, Syrian-type text, or Alexandrian as a standard cannot be an absolute, Biblical final authority, for a Greek text is NOT the Bible!

These are internal proofs, external proofs, numerical proofs, historical and prophetic proofs and especially Biblical proofs of God's work, **"Remember that thou magnify his work, which men behold"** (Job 36:24).

Is there anyone naive enough to believe that the God of all creation, Who preserves everything, (Col. 1:17) was unable to preserve His words in more than three languages (Hebrew, Aramaic, and Greek)? If God can preserve a man's life as He did with Joseph (Gen. 32:30; 45:5, 7) and David (2 Sam. 8:6) and preserve His people (Psa. 41:2), and can [**"preserve] the way of His saints"** (Prov. 2:8), Whose **"eyes...preserve knowledge,"** Who **"...overthroweth the words of the transgressor,"** (Prov. 22:12), The Lord God Almighty can very simply and does [**"OVERTHROW] the WORDS of a transgressor."** In this case any critic of the King James Bible. Isaiah spake concerning the preserving power of God Almighty and His chosen people, Israel,

**"Thus saith the LORD, In an acceptable time have I heard thee, and in a day of salvation have I helped thee: and I will PRESERVE thee, and give thee for a covenant of the people, to establish the earth, to cause to inherit the desolate heritages;"**

Now how is that for a promise? Stalin couldn't eliminate the Jewish people. Hitler couldn't eliminate them. No world power has been able to blot out Israel. Do you know why? Very simple. The God of the Bible says so! THAT'S why!

God has seen fit to preserve those in Christ (Jd. 1:1). So, only a fool would doubt the preserving power of God to keep His word, word-perfect in the international language of English and in no other.

**"For all the promises of God in him are yea, and in him Amen, unto the glory of God by us,"** (2 Cor.1:20) and He promised to PRESERVE His words, all of them in the form that He would want for the whole world (Psa. 12:6, 7). As a matter of fact, a translation makes the things even *better* (2 Sam. 3:10; Col. 1:13; Heb. 11:5). And He has done that with the King James Bible. He gave it to a king (King James) who under the leadership of God Almighty had the greatest event take place for so many translators to gather, work together for seven years (number of perfection) to complete the greatest translation that ever took place in the history of man, let alone the Church Age. That text, the King James Bible is THE text for the whole world from which to translate in their own languages the Bible. To return to the 'originals' is absolutely foolish, for God knew that less than one percent in the world would understand Greek, let alone the 'originals' and even less amount would speak Hebrew. The Lord did all the 'homework' with that great event of the translators of the King James Bible that gathered all the necessary manuscripts, translations for comparison and other material to put together ONE BOOK, the King James Bible. To go back to the 'original' languages and try to translated from them (Hebrew and Greek) will only cause more division in the body of Christ. To profess to have the 'originals' is simply the figment of one's imaginations just like the silly professors (Rom. 1:22) of evolution who profess to have found the missing links between animals and man. It is simply 'hot air.'

## For The Whole World...

The Lord Jesus Christ did everything for you. He came to this sinful world. He suffered, hungered, thirsted, was persecuted, shed His blood for you, was forsaken by the Father for you, became a curse for you (Gal. 3:10, 13) and suffered the wrath of God (Jn. 3:36) and His soul suffered HELL (Isa. 53). He did ALL the homework. There is NOTHING you can do to add to that. There is nothing that can be taken from it. In the Church Age, salvation is a free gift (Rom. 5:16-18; Eph. 2:8, 9). To go back to the other side of the cross to pull the law across over to the “dispensation” of the Church Age, to the body of Christ as a means and part of salvation to be saved and to remain saved means that you make the cross of none effect and then Christ has died in vain, **“I do not frustrate the grace of God: for if righteousness come by the law, then Christ is dead in vain”** (Gal. 2:21).

APPLICATON: As nothing can be added to the cross and nothing taken from the cross so nothing can be added to what the Lord did with the King James Bible historically. You cannot add to that, (improve upon it) or take from it. Even so, you cannot add to the King James Bible nor take from it. It is a historical landmark!

...so He has done all the ‘HOMEWORK’ for you at **1611, for the whole world!**

The very same thing is what God did with the King James Bible. He did all the ‘homework’ for the world. The best of the Hebrew and Greek scholars known along with the best of vernacular and tried versions of the Bible were gathered along with Hebrew and Greek manuscripts, so the end result would be an INTERNATIONAL (thus – “in-there-nation”) translation – borrowing from various languages, and then giving to each nation a TRANSLATION, being better than the ‘originals.’ He has given them His pure words in the international language of English so that anybody could see and understand what exactly He said. God promised that He would keep His words pure (Psa. 12:6, 7). His words are pure (Prov. 30:5; Lk. 4:4) and He is able to keep them. They are top priority (Psa. 138:2). They are to be praised (2 Thess.3:1). They are to be preached (2 Tim. 4:1-2). But how can you preach God’s pure words if critics of the Bible are perverting His words? It makes it very difficult when very few people are interested in what God said. But God, in His keeping power HAS preserved His words for the whole world to see them, hear them and even hold them in their hands. Such an event had never taken place before in the history of man let alone in the Church Age and has never been repeated since. The English language itself is above any other language in the history of man. It is a language which has many borrowed words from various languages; Gothic, Latin, French, German, etc. and incorporated into a ‘self-standing’ language which has by far more words in its volume than any other language in the world. That is what God has given back to every nation on this earth. From GOD’S ETERNAL WORDS IN THE ENGLISH LANGUAGE men are to translate into their own local languages. For since God has one STANDARD IMAGE - THE LORD JESUS CHRIST (2 Cor. 4:4; Heb. 1:3), there is *ONE STANDARD OF HIS PURE WORDS* – THE KING JAMES BIBLE. And to get the most revelation of God’s image – the Lord Jesus Christ on paper you must get your recourse from the true fountain of life, the Holy Authorized Version of the King James Bible. So, AS there cannot be two Jesus Christs SO there cannot be two standards on this earth by which to judge things. There is only one or else that would be a misrepresentation of Who God is. And that is exactly what the devil wants – many representations of ‘truth’ so as to cause CONFUSION, **“For God is not the author of confusion...”** (1 Cor. 14:33).

Now, getting back to the subject at hand, a decree was made by another king, Darius, who wisely decreed that the words of his law shall never be altered without punishment. **“Also I have made a decree, that whosoever shall alter this word, let timber be pulled down from his house, and being set up, let him be hanged thereon; and let his house be made a dunghill for this,”** (Ezra 6:11).

Alexandrian scholars do not believe God has preserved His word (Psa. 12:6, 7), but they will be punished severely for their unbelief (Prov. 30:5, 6; Rom. 1:18, 25; Rev. 22:18-19). If they are saved ‘Alexandrians’ they will lose much rewards and their works will be burned at the Judgment Seat of Christ (1 Cor. 3:11-15) for such deception.

#### Step no. 4

The *signing* of the decree by his own name –

“Then were the king’s scribes called at that time in the third month, that *is*, the month Sivan, on the three and twentieth *day* thereof; and it was written according to all that Mordecai commanded unto the Jews, and to the lieutenants, and the deputies and rulers of the provinces which *are* from India unto Ethiopia, an hundred twenty and seven provinces, **unto every province according to the writing thereof, and unto every people after their language, and to the Jews according to their writing, and according to their language.**

And he **wrote in the king Ahasuerus’ name**, and sealed *it* with the king’s ring, and sent letters by posts on horseback, *and* riders on mules, camels, *and* young dromedaries:” (Esth. 8:9, 10).

We are reminded that when the King makes a decree that, that decree had *power* and *authority*, “Where the word of a king *is*, *there is* **power**: and who may say unto him, What doest thou?” (Eccl.8:4). But the king has to put his name to it therefore the decree must be SIGNED.

In Daniel 6:8 we are provided with additional revelation concerning the power of a king by his own signing of a decree –

“Now, O king, establish the decree, and **SIGN the writing**, that it be not changed, according to the law of the Medes and Persians, which altereth not.”

The signing of the decree would be equivalent to a man’s signature to give authentication to an official document. We say, “Sign on the dotted line.” That is where you put your ‘John Henry’ down. The signing of the decree is what gave the words of the decree of a king power and AUTHORITY. Likewise that is the ‘stamp’ of what the ‘King’ Jesus says. He backs up **“every word”** (Prov. 30:5; Mt. 4:4; Lk. 4:4) by his very NAME! Amen! He says what He says because He is Who He is. He is God. So Kings are in used of God for His purpose **“The king’s heart is in the hand of the LORD, as the rivers of water: he turneth it whithersoever he will”** (Prov. 21:1).

“For unto us a child is born, unto us a son is given: and the government shall be upon his shoulder: “and his name shall be called Wonderful, Counsellor, The mighty God, The everlasting Father, The Prince of Peace,” (Isa. 9:6).

His name is **“The Word Of God,”** (Rev. 19:13). That is power! That is AUTHORITY!

Jesus Christ backed everything up by His very name. All that He did while He was on this earth ministering, preaching and teaching and all that He said is ‘signed’ by His very NAME and sealed by the Holy Spirit of God.

So, God used King James for there to be ONE STANDARD that would be signed, that is, authorized by King James, a translation ‘signed’ by God’s signature and seal (stamp) of approval. There is One, True King that is approved of God. Peter spoke of Him,

“Ye men of Israel, hear these words; **Jesus of Nazareth, a man approved of God** among you by miracles and wonders and signs, which God did by him in the midst of you, as ye yourselves also know:” (Acts 2:22).

So just as Jesus Christ, the King of the Jews was approved of God, there is only one King that gave approval, signed his own name to a translation, where the translation was in an international language – King James. The King James Bible is the only Bible on the market today that speaks of [**“studying] to show thyself approved unto God...by rightly dividing [it]”** (2 Tim. 2:15). All the modern versions have CORRUPTED THAT VERSE going against their own Greek texts.

#### Step no. 5

The words of the decree of the king are **sealed** –  
“in the name of king Ahasuerus was it written, and **sealed with the king’s ring,**” (Esther 3:12).

“Write ye also for the Jews, as it liketh you, in the king’s name, and **seal it** with the king’s ring: **for the writing which is written in the king’s name, and sealed with the king’s ring, may no man reverse,**” (Esther 8:8).

“And he wrote in the king Ahasuerus’ name, and **sealed it** with the king’s ring, and sent letters by posts on horseback, *and* riders on mules, camels, *and* young dromedaries:”  
(Esth.8:10)

This is the most important part since what the King says, that’s the way it is going to be without any infraction. The decree is first spoken, then committed to writing, then *SIGNED*, *SEALED* and then it is *DELIVERED!*

This step speaks of the *preservation* of those words of the decree and marks one’s distinctive character –

The words of the king are sealed –

1.) Sealed in a sense from those that may disagree with the decree. Therefore they cannot reap the benefits of that decree. That would be like many apostate ‘Christian’ that are so foolish to pervert the words of God (Jer. 23:36), subtract from the words of God (Deut. 4:2), add to the words of God (Deut.4:2) or take those words out of context. Therefore the words of God are sealed unto that critic of the King James Bible.

It was Jesus Christ Himself that said,

“In that hour Jesus rejoiced in spirit, and said, I thank thee, O Father, Lord of heaven and earth, **that thou hast hid these things from the wise and prudent, and hast revealed them unto babes:** even so, Father; for so it seemed good in thy sight” (Lk. 10:21).

This time it was the apostle Paul that said,

“For it is written, I will destroy the wisdom of the wise, **and will bring to nothing the understanding of the prudent,**” (1 Cor. 1:19).

So the word of God is “sealed” in the sense, kept ‘shut up’ from the critics of the King James Bible.

“For example, in July of 2009 First Baptist Church of Hammond, Indiana sponsored a so-called ‘KJV Summit’ at their Hyles-Anderson College. Unfortunately, it promoted many of the standard criticisms and misinformation about the KJB. It was held in response to a revealing letter co-founder Russell Anderson wrote to all students, faculty and graduates. In the letter, Dr. Anderson stated that he was upset because Jack Schaap, the pastor and chancellor of the college stated in his book, *Where Are We Going?* (and in various sermons) that he did NOT believe in the inspiration of the King James Bible, as did the founder. (Schaap had pleaded guilty and is now in jail for other reasons, for a federal offense.)

Around 1,600 men and women came from all over America to hear what had been advertised as a King James Bible Summit, where their faith in the KJB would be strengthened.

Bible teachers from Hyles-Anderson College, Phil Pins and Darrell Moore cited the Ukrainian upstart, Yuro Popchenko, (one more liar for Ukraine), who studied Hebrew and Greek in Moscow. But, fortunately, Gail Riplinger, a woman, found out Popchenko’s sin.

At the KJV Summit, a CD-Rom was distributed to attendees. It contained a file entitled, ‘Schaap Modern Missionary Translators’.

(This is file number one (58.4 kb), not the similarly titled PowerPoint presentation.)

It appears to be the typed original lecture notes of Dr. Darrell Moore and contains material that he did not say at the conference, but was intended to be read by the attendees later.

In it Moore cites favorably a statement by missionary to the Ukraine, **Yuro Popchenko**, suggesting the doctrinally similar reading, “Jesus **to be** the Lord” **instead of that of the KJB.**

The missionary, Yuro Popchenko, **mistakenly says,**

“For example, in Romans 10:9 the Lord Jesus is double accusative, (the phrase meaning ‘if you confess Jesus **to be** the Lord’), and it is **obvious only from the Greek...**”

**In fact, the GREEK text** does not have a “**double** accusative,” as he states, since it does not add words, such as “as,” “is,” or “**to be.**”

KJB and <b>all Greek texts</b> in Romans 10:9 say:	“ <b>the Lord Jesus.</b> ”
RV 1881 and	Jesus <i>as</i> Lord (see italics)
<b>NASB, TEV say</b>	Jesus <i>as</i> Lord (see italics)

**Accusative is the case expressing the goal of an action; in English it is the objective case. Italics were used because the Greek has NO SUCH double accusative!!!!**

– slide 23 –

Later, **translators who taught works for salvation** started adding “**is**” using **NO ITALICS**. Remember, the word “is,” “as” or “to be” is not in the Textus Receptus or even the Nestle’s text.

(Vaticanus adds “that,” not “is.” i.e. ‘that Jesus Lord’, implying “is.” Metzger, Textual Commentary.)

<b>Jehovah Witness</b> New World Translation, <b>Catholic</b> New American Bible, <b>Catholic</b> Jerusalem Bible, <b>Catholic</b> Confraternity, ASV, NIV, RSV, LB, ESV, HCSB, NEB, etc., all say	“Jesus is Lord.”

Why did the **1881 Revised Version** begin this **imaginary** “double accusative” with their italics?

The Church of England, like the Catholic Church, teaches **works** and sacrament-based salvation.

Translators **Westcott, Hort, Vaughan, Stanley, and Ellicott** despised ‘evangelicals’ who taught salvation by grace through FAITH.

Use of erring dictionaries, such as **Vine’s Expository Dictionary**, cited in the **Summit Bibliography**, may be the source of this error.

By changing the Bible here, W.E. Vine and John MacArthur lean toward Lordship salvation.

Vine says, “When he expounds the **conditions** upon which salvation is to be possessed, he stresses the necessity of **acknowledging the Lordship** of Christ: If thou shalt confess with thy mouth **Jesus as Lord...**”

The bibliography file on the same Summit CD-ROM cites Vine’s and other corrupt lexicons and books, which will encourage readers to:

- 1.) Think that the KJB is not inspired.
- 2.) Mistranslate new foreign language editions, thereby **matching new versions**.

Again Moore’s lecture notes, citing Yuro Popchenko, **fault the common interpretation of the KJB** in another verse by quoting Popchenko, who said,

“However, in Genesis 22:8 ‘**provide himself a lamb**’ is NOT a double accusative but a dative with accusative, **in spite of common interpretation** (the phrase meaning, God will provide a lamb for Himself) and this is obvious only from the Hebrew.”

The translator (Popchenko) says it is “**a dative with accusative in spite of common interpretation.**”

He is hereby suggesting that the **common KJB** translation of Gen. 22: 8 “God will provide himself a lamb...” is **WRONG!**

The KJB says, “God will provide **himself a lamb.**” **God becomes the lamb.**

The Summit lecture notes say the meaning is “God will **provide a lamb for Himself.**” This infers: God *gets* the lamb; he is not the lamb of God. Jesus is not God manifest in the flesh.

John will provide **himself a servant.** – John becomes a servant.

John will provide **a servant for himself.** – John will get someone else to be his servant.

Accusative is usually the fourth case of declinable words corresponding to the objective in English; dative: the doing of something to or for; it follows verbs that express giving. *The Webster’s Encyclopedic Dictionary.*

– slide 33 –

They say, “**this is obvious only from the Hebrew.**”

The **KJB, RV, ASV, and RSV** translators must not speak Hebrew, as all of these translated it “**God will provide himself a lamb...**”

**WHY??** The word “for” is NOT IN THE HEBREW; it must be **added** to make it “a dative with accusative.”

Dative is expressed by *to, for*, or word order; e.g. I did the work for Jack Schaap. An indirect object of a verb (*Webster’s New Universal Unabridged Dictionary*).

Gradual falling away	Genesis 22:8
<b>Step 1</b> Catholic New American Bible, NIV, Holman Christian Standard Bible.	“God Himself will provide the lamb.”
<b>Step 2</b> NASB, NKJV, ESV	THEY MOVE THE WORD “HIMSELF”!! But they still know that the word “for” is not in Hebrew.
<b>(Summit CD-Rom: “God will provide a lamb for Himself”</b>	“God will provide <u>for</u> himself the lamb. “For” is added using no italics to indicate no Hebrew.

Summary

A missionary translator (Riplinger is referring to Popchenko) who *says* he is accessing **THE GREEK and THE HEBREW** may often really be accessing only **corrupt reference books** which lead to the **liberal interpretations of the modern versions**, which used the same corrupt books.

That is Yuro Popchenko for you! He was once a member of Bible Baptist Church of Kiev and sat under the teachings of this author in Greek class.

This author did a critique of the Gospel of John translated into the Ukrainian language by Yuro Popchenko. We sent out an ‘**All Points Bulletin**’ to pastors in the United States to warn them of Popchenko’s position concerning his corruption of a translation of the Bible in the Ukrainian language using a Textus Receptus text and using words that are found in the *New International Version*. For further information concerning the apostasy at Hyles-Anderson College you can read a letter written by Mr. Anderson after whose name, Hyles-**Anderson** College (Indiana) was named and how that the Fundamentalist college had gone apostate when Jack Hyles' son-in law, Jack Schaap became pastor <http://hacalumni.com/DrRussellAndersonNote.shtml>

Unfortunately, Schaap had failed miserably (Psa. 12:1). The problem lies much deeper; it is *his rejection of the King James Bible as the inspired word of God*. A fleshly fall is one thing. What is even worse is that pride has ensnared him for he doubts the very words of God preserved in the King James Bible. That will do much more damage to the name of Biblical Christianity than anything else. It was Satan that said, **"Yea, hath God said..."** (Gen. 3:1).

Beware when someone puts a question mark on the Holy Bible (KJB) and does not "tremble" at his word (Isa. 66:2).

In short, the King James Bible is "sealed" from Jack Schaap and Yuro Popchenko no matter how much 'good' they may attempt. Both are apostates. **"In that hour Jesus rejoiced in spirit, and said, I thank thee, O Father, Lord of heaven and earth, that thou hast hid these things from the wise and prudent, and hast revealed them unto babes: even so, Father; for so it seemed good in thy sight,"** (Lk. 10:21).

"For I know this, that after my departing shall grievous wolves enter in among you, not sparing the flock.

Also of **your own selves** shall men arise, **speaking perverse things**, to draw away disciples after them.

Therefore watch, and remember, that by the space of three years I ceased not to **WARN EVERY ONE** night and day with tears," (Acts 20:29-31).

It was the Psalmist that said, **"Help, LORD; for the godly man ceaseth; for the faithful fail from among the children of men,"** (Psa. 12:1). One of the major failures of 'godly' men has to do with the association of the preservation of the words (plural) of God (Jn. 4:34; 5:47; 6:63, 68; 7:9; 8:20, 30, 47, Psa. 12:6-7, etc). When these men fail to believe the clear promise of God to keep His words pure, that is, since 1611 A.D. in the King James Bible, they resort to extrabiblical recourses; *"the Greek"* *"...the originals"* *"...a better rendering is..."* *"the oldest and best manuscripts..."* *"I prefer the RSV..."* *"the Septuagint reads..."* etc.) Textual critics are double-minded by using dual authorities and yet they believe in the verbal plenary inspiration of the Scriptures in the original autographs, but they have never seen the originals (Jer. 36).

People that corrupt the pure words of God claim the inspired words of the original autographs are sufficient as the only infallible rule of faith and practice, but they do not have the original manuscripts. The so-called "scholars" foolishly believe that God is not able to preserve His words from error; therefore, their own personal preferences become their final authority. They do that for two reasons: First, they not only want their words to replace the words of God (Psa. 12:4; Jer. 23:25-40), and secondly, they like the idea of people believing them instead of what God has preserved in the Reformation text of the AV 1611 in the international language of English. They become the middle-man, a 'god,' just like an earthly,

pagan priest, a Vicar. When *godly* men fail, others follow suit. “...a little leaven leaveneth the whole lump.”

2.) The word “sealed” also carries the meaning of *finality*. God spake and He also has the last say so on ANY issue. It will be in the end that the “words of God” will judge people (Prov. 19:21).

That is the principle by which the King James Bible is to be applied. It is THE FOUNDATION by which all other translations are to be translated since 1611. The completion of the King James Bible was in accord with the plan of God for English to become the end-day, universal language. With the standardized time and location being determined in Greenwich, England, NOT Jerusalem (Hebrew language) NOR Athens, Greece (Greek language) and even the proper temperature readings established by British thermal units, men would henceforth look to this same island nation to secure the correct Bible.

### The signing and sealing of a decree

Now let’s look at WHY it was the practice of Kings to sign and seal their decrees.

Again the book of Daniel 6:7 provides us the *reasons* for the signing and sealing of a decree –

“And a stone was brought, and laid upon the mouth of the den; and the king **sealed it with his own signet**, and with the signet of his lords; **that the purpose might not be changed concerning Daniel.**”

Some of the most famous preachers are some of the most blinded people in the body of Christ. They do not and cannot see the “**purpose**” of one standard Bible, (and not all the other “Standards” – *New American ‘Standard’ Bible* or the *New Revised ‘Standard’ Bible*, etc.).

For instance John MacArthur has a world-wide ministry. His sermons are translated into many languages. He uses a modern version of the Bible. There are about 30,000 departures from the **truth, and many** of the readings in the modern version that MacArthur uses are from Alexandria, Egypt, from the Septuagint. There is no possible way you could apply the verse “**Where the word of a king is, there is power: and who may say unto him, What doest thou?**” (Eccl.8:4).

What ‘king’ was ‘reigning’ when the Septuagint was produced by Origen? Origen’s fifth column of Hexapla was produced over 150 years *after* the canon of the New Testament was completed. MacArthur, and so many more TV, or Internet preachers are LATE. They’ve chosen corrupt manuscripts when NO king was reigning except in Rome. And all roads lead to Rome!

So all the principles concerning the decree of a king; the power and authority, the principle of a decree coming from a world power, whose influence was world-wide could NOT possible apply to the modern versions. But it most certainly applies to the King James Bible.

No matter what the decree of the King consisted of it was to be *fulfilled* according TO THE WRITING –

“**according to the law**” (Esther 1:7, 8, 15)

“**according to the word**” (Est. 1:21)

“**according to the writing** (Est. 1:22; 3:12)

Translators are to translate with the approval of the king and it is to be sealed with the King’s ring. Any translation in a foreign tongue ought to be from the King James Bible. That is THE Biblical method. It cannot be reversed! That is the character of the King James Bible which best represents King Jesus’ character and person. He is light. He moves. He has advanced further to an international language of English and has sealed His words in the name of a KING – King James. Plain and simple!

“Write ye also for the Jews, as it liketh you, in the king’s name, and **seal it** with the king’s ring: **for the writing which is written in the KING’S NAME, and sealed with the king’s ring, MAY NO MAN REVERSE,**” (Esth.8:8).

Unfortunately, many a preachers, especially English and American have done a ‘reverse,’ an ‘about face.’ They are turncoats, apostates! They left ‘the Book,’ the standard that made England and America great countries. America is still producing missionaries that are being sent all around the world and taking their King James Bible with them. Men like John MacArthur, Charles Stanley, hundreds of New Evangelicals and others from many other denominations backpedaled, ‘backslid’ back to the ‘originals’ and are simply blinded to the fact of the “**purpose**” of God ‘signing’ and ‘sealing’ by His Holy Spirit the greatest book that has ever been WRITTEN, that is AVAILABLE right now, that you can hold in your hands, (and not some ‘original’ autographs that nobody has), that people still preach from, teach from, think on, meditate on, and TRANSLATE FROM – the AUTHORIZED KING JAMES BIBLE. It is by far (to say the least), with no shadow of doubt, hands down (American idiom), more powerful than any other version (including any Hebrew and Greek manuscripts), more influential than any other version, the great work of God’s providence, like so many other miracles of God Almighty.

In that sense, then the pure, preserved, perfect words of God are “**SEALED**” so that if a man whose heart is not open, whose mind is not humbled enough to understand this all-important issue concerning the words of God, then those words are sealed to that man, shut up, closed. For in Isaiah 29:11-14 we are provided with some real ‘eye-opening’ revelation. For Isaiah had to deal with the very same problem that is going on today –

“And the vision of all is become unto you as the **words of a book that is SEALED**, which *men* deliver to one that is learned, saying, Read this, I pray thee: and he saith, I cannot; **for it is SEALED:**

And the book is delivered to him that is not learned, saying, Read this, I pray thee: and he saith, I am not learned.

Wherefore the Lord said, Forasmuch as this people draw near *me* with their mouth, and with their lips do honour me, but have removed their heart far from me, **and their fear toward me is taught by the precept of men:**

Therefore, behold, I will proceed to do a marvellous work among this people, *even* a marvellous work and a wonder: **for the wisdom of their wise *men* shall perish, and the understanding of their prudent *men* shall be hid,**”

The ‘wisdom’ of the wise in this context has nothing to do with what God said. “**This wisdom descendeth not from above, but is EARTHLY, SENSUAL, DEVILISH. For where envying and strife is, there is CONFUSION and every evil work,**” (Jam. 3:15, 16).

The multiplicity of ‘bibles’ is THE most important factor why there is so much CONFUSION in the body of Christ, let alone in the modern world. The Devil, “**the god of this world**” (2 Cor. 4:4) is behind the dastardly work of the false versions of the Bible and continues to deceive more and more people into thinking that there can’t be ONE STANDARD and ONE AUTHORITY! And unfortunately that are hundreds of preachers and teachers that are caught up in this “‘**Yea, hath God said,**’ society,” (Gen. 3:1) or conspiracy. Whether they know it or not, whether consciously or unconsciously the apostates are deceived and continue to be used by the Devil to deceive others (2 Tim. 3:13).

When dealing with the words of God being sealed let’s take a look at Daniel 12:4 where Daniel is told to “**shut up** the words, and **seal** the book, *even* to the time of the end: many shall run to and fro, and knowledge shall be increased.”

If that weren't enough we read further in Daniel 12:8, 9 –

“And I heard, **but I understood not**: then said I, O my Lord, what *shall be* the end of these *things*? And he said, Go thy way, Daniel: **for the words are closed up and sealed** till the time of the end. Many shall be purified, and made white, and tried; but the wicked shall do wickedly: **and none of the wicked shall understand; but the wise shall understand.**”

Here the word “**sealed**” has to do with a man *not understanding what is written* that others later *would* understand. When Daniel was given the prophecy he said, “**but I understood not...**” (v. 8). So then those words of prophecy which were given to Daniel that were “**shut up**” (Dan. 12:4), “**closed up**” (Dan. 12:8) and “**sealed**” (Dan. 12:4, 8) would be eventually understood by others *later*. That is what you call *progressive revelation*. There are a number of things that Old Testament saints couldn't ‘get’ but was later revealed.

For instance many of the prophets didn't “**understand**” that there would be a period of about 2,000 years between the suffering and the glory of Jesus Christ. For in 1 Pet. 1:11 we read, “Searching what, or what manner of time the Spirit of Christ which was in them did signify, when it testified beforehand **the sufferings of Christ, and the glory that should follow.**”

Although the mystery of the Body of Christ was mentioned in the Old Testament, the saints back then couldn't figure it out. That mystery is about the church period where the Jew and the Gentiles would be in one body of Christ and by Christ. That was unknown to the Old Testament saints. But that mystery was *later revealed* to Paul. You see, he ‘got’ the “**understanding**” that the Old Testament prophets didn't “**understand.**” Not even Peter, John, Matthew, Mark, knew about it. It was revealed to the apostle Paul. The revelation was PROGRESSIVE! To reject this Biblical example of progressive revelation is simply to show your ignorance and lack of Bible study (2 Tim. 2:15).

#### ENTER ADVANCED REVELATION OF THE KING JAMES BIBLE

While continuing the thought of a decree being “sealed” it is also of most importance to expound upon the fact of something else has been sealed and why. The advanced revelations of the King James Bible are littered all over THAT Book! Only an ignorant Fundamentalist, (let alone your ignorant Neo-Evangelicals), who has put tithing, ‘standards,’ church attendance and especially soul winning on a pedestal can't see some of the most obvious advanced revelations in the King James Bible that no Greek or Hebrew text will ever give you. There are literally hundreds of advanced revelations in the King James Bible. [For a more in-depth study concerning this subject see our book ‘**Advanced Revelations of the King James Bible that no Greek or Hebrew Text Has**’].

We've already touched on a few of them but here we will list only a few more. To reject the advanced revelations in the King James Bible is to reject what God has set up. God has set up ONE FINAL AUTHORITY and NOT two. If you are to accept dual authorities; the King James Bible AND the ‘originals’ or the King James Bible AND ‘the’ Textus Receptus, (although they have been corrupted and there are a number of Textus’ Receptus’) or “The Word of God” (which means nothing) AND the King James Bible, you are a double-tongued hypocrite and you haven't got the

inner fortitude to stand in the gap for absolute truth. You are still 'CATHOLIC' (dual authorities) at heart. You are trying to play it safe but you will not 'advance' fully to the King James Bible as the Lord Himself advanced His words, made them more perfect, more excellent, purified them more so. Cannot gold be purified many times? Of course it can. You are a coward, a traitor to God and your fellow man if you cannot see 'what God hath wrought' using about fifty translators in 1611 in England in the international language for the whole world, prepared His text in perfect fashion. You may not think that but that is because your conscience has not been awakened. Well, it's time to wake up! 'Get with the program' dear friend.

### **The AV exposes the Hierarchy of the Roman Catholic System**

How is that Done?

1. In the King's English the hierarchy of the Roman Catholic system; Roman Pontiff, cardinals, priests, is laid out, whereas in the Greek texts (any of them) the different ranks of a priest-class are not revealed as such.

- The reason for that is there was only a Gentile Roman power during the time when the international language was Greek. There was no Roman Catholic Church hierarchy. ---

- Therefore Greek manuscripts, NOT EVEN THE ORIGINALS would have had to say anything about that system.

- It wasn't until some 300-400 plus years *AFTER* the completion of the New Testament writings the Roman Catholic Church system was formed in its entirety. John PROPHESED about it.

- Prophecy means that WHICH IS TO COME. That means it didn't exist then.

In Matthew 26:3 we read the following – **“Then assembled together the CHIEF PRIESTS, and the scribes, and the elders of the people, unto the palace of the HIGH PRIEST, who was called Caiaphas,”**

Notice in this verse as in other verses that there is a class of **“chief priests”** and also another class, the **“high priest.”** Those *two classes* come from the same Greek word

ἀρχιερέως

The Authorized Version gives 4 classes of a priests whereas in any and all Greek texts (Alexandrian or Antiochan) there are listed only 3 –

(1.) **“the great high priest”** is Jesus Christ (Heb. 4:14). He is separate, and sinless.

So we'll put Him in a separate category.

But there are *three other ranks* of priests on the earth.

(2.) “high priest(s)” (the Greek word is pronounced Arch-khee-eh-re-oos)

(3.) “chief priest(s)” the same word - Arch-khee-eh-re-oos)

(Note in all Greek texts the word for “high priest” (No. 2) is the same exact word used for “chief priest” (No. 3) *without any distinction except in the plural.*

(4.) “priest(s)” the lower ranked priests.

So, which text best attacks and stabs the whorish Roman Catholic System? Of course the King James Bible.

That's why any Bible perverter is Roman Catholic at heart if he doesn't take a firm stand on the King James Bible. The King James Bible cuts through that system and exposes it for what it is – WICKED.

If a man is going to be a Bible believer he automatically becomes ANTI-CATHOLIC because of its wicked, pyramid-system of a hierarchy that the King James Bible EXPOSES! Greek manuscripts here and as in so many other places simply don't 'cut the mustard.'



## “Easter”

“Easter” (Acts 12:4) is NOT in any manuscripts **“And when he had apprehended him, he put him in prison, and delivered him to four quaternions of soldiers to keep him; intending after Easter to bring him forth to the people.”**

Secondly, the development of the word “Easter” is simply a different pronunciation or another form of the word “Ashteroth,” also pronounced “Ishtar,” (found on the Assyrian monuments and also from Nineveh) or “Astarte,” (named after the Syrian goddess) which was introduced very early into Britain, along with the Druids.

Again, the AV shows the connection of Ashteroth, (Astarte) of the Old Testament Babylonian worshipping of a female goddess known as **“the queen of heaven”** (Jer. 7:18; 44:17-25)

When understanding words in The Holy Bible looking at the root of a word helps very much. In the case concerning the word **“Easter”** the English word **“East”** means something. The King James Bible prophesizes of the end times of what kind of religion will be the world religion under the antichrist. TODAY it is the worship of a woman that began in the EAST – BABYLON. That woman is promoted and exalted by a church, the ROMAN CATHOLIC CHURCH. She is spoken of in Revelation 17:5, **“And upon her forehead was a name written, MYSTERY, BABYLON THE GREAT, THE MOTHER OF HARLOTS AND ABOMINATIONS OF THE EARTH.”** Anybody knows that that religion is not a Jewish religion. It is a PAGAN religion. It’s system and doctrines are the cause of more people getting killed for any other reason, **“And in her was found the blood of prophets, and of saints, and of all that were slain upon the earth”** (Revelation 18:24). We’re dealing with a system and a spirit that existed even before there ever was a Jew on top side of this earth.

Today this “queen of heaven” is Mary of the Roman Catholic WHORE, a woman church that has a woman goddess. Greek manuscripts will not help you at all here in Acts 12:4 concerning this truth.

“Ashteroth” as mentioned in the Bible is not only a geographical place, but also the name given to a *female goddess* worshipped by heathen. Various Bible land maps have its location about 40 kilometers east of the Sea of Galilee. The name “Ashteroth” is found in the following verses (Gen. 14:5; Deut. 1:4 (**“Astoroth”**)) Josh. 9:10; 12:4; 13:12, 31; Judg. 2:13; 10:6; 1 Sam. 7:3, 4; 12:10; 31:10; 1 Kings 11:5, 33; 2 Kings 23:13; 1 Chron. 6:71). It is connected with pagan, Gentiles, and giants that were enemies of God and Israel. Later Israel went into apostasy. Note Judges 2:13 **“And they [the Jews] forsook the Lord and served Baal and Ashteroth”**

This is the seventh great mystery revealed in the holy scriptures that talks about that religion from the EAST. The holiday that is practiced among many people, tongues, nations, is EASTER. Herod, a wicked king was not connected with “Passover” (a Jewish designation) but with his own Gentile wicked holiday, **“EASTER.”**

The Holy Bible (AV 1611) is the only Bible on earth in the international language of English that has this revelation. The significance of this word is that it is the only place in the New Testament that exposes with what religion the leaders in the end times will be connected – the worship of a woman that started in the EAST. Therefore “Easter” is a far better word than Passover.

Doctrinally it also can be proven that “Passover” (Grk. “pascha”) was celebrated on the 14<sup>th</sup> of the first month of the Jewish calendar. Then started the feast of unleavened bread called **“the days of unleavened bread,”** from the 15<sup>th</sup> day till the 21<sup>st</sup>. That is what is in Acts 12:4 **“(Then were the days of unleavened bread.)”** That is seven days *SEPARATE* from the 14<sup>th</sup> day of Passover. The offering required on the 14<sup>th</sup> day is *DIFFERENT* from the offerings that were brought from the 15<sup>th</sup> to the 21<sup>st</sup>. And no combining the two different offerings will do any good. Ezekiel 45:21 has a

COMMA in it that separates “**the passover**” (comma) from “**a feast of seven days; unleavened bread shall be eaten.**”

Note first of all “**THE day**” or “**THE Passover**” mentioned – (Lev. 23:5; Num. 9:5, 6; 28:16; Josh. 5:10; 2 Chron. 30:15; 35:1, 16; Ezra 6:19; Ezek. 45:21).

Notice also “**the feast of unleavened bread**” (Exod. 12:17). Then notices “**the days of unleavened bread**” (Exod. 12:15).

That means that the Greek word “pascha” is an “out of date” word because nobody today could ever connect Herod with his Old Testament pagan practice of Ashteroth, Astarte, unless the “up to date” Authorized Version had “**Easter**” there.

That is PROGRESSIVE REVELATION in “**the holy scriptures**” (Rom. 1:2; 2 Tim. 3:15) preserved by the Holy Spirit Himself in the international (not local or national) language of English.

The Greek word “pascha” (in all extant Greek texts – Antiochan; Beza, Scrivner, or Alexandrian; Westcott and Hort, Aland, Metzger, etc.) is a “misfire” compared to the KOBALT BOMB of “**Easter**” in “**the holy scriptures**” (Rom. 1:2; 2 Tim. 3:15) of the AUTHORIZED Version (1611). The Catholics know that. That is why the Jesuits tried to kill King James by putting a supply of dynamite under his house to kill him. That was a “misfire” also! Guy Fawkes ‘got the ax.’

On 31 January 1606, Fawkes and three others – Thomas Wintour, Ambrose Rookwood, and Robert Keyes – were dragged (*i.e.*, “drawn”) from the Tower on wattled hurdles to the Old Palace Yard at Westminster, opposite the building they had attempted to destroy. His fellow plotters were then hanged and quartered. Fawkes was the last to stand on the scaffold. He asked for forgiveness of the King and state, while keeping up his “crosses and idle ceremonies” (Catholic practices). Weakened by torture and aided by the hangman, Fawkes began to climb the ladder to the noose, but either through jumping to his death or climbing too high so the rope was incorrectly set, he managed to avoid the agony of the latter part of his execution by breaking his neck. His lifeless body was nevertheless quartered and, as was the custom, his body parts were then distributed to “the four corners of the kingdom”, to be displayed as a warning to other would-be traitors.

For modern man that would be ‘gross’ as they say. But what about what will happen to our brethren in Christ when they will have to deal with a holy ‘**FIRE**’ at the Judgment Seat of Christ (1 Cor. 3:13, 15) for such dastardly deception teaching that we need to go to ‘the Greek’ or to the Septuagint or translate from a Textus Receptus, etc. failing to see so much revelation in the King of books – the AV.

#### Advanced revelations in the italics of the King James Bible

What about all the places in the King James Bible where you find *italics* like in 2 Samuel 21:19 where you read, “...Elhanan the son of Jaareoregim, a Bethlehemite, slew ***the brother of Goliath*** the Gittite...” No Hebrew text gives you THAT revelation. There are literally TENS of places of *italics* throughout the entire Bible that no Hebrew or Greek text supplies that actually add revelation.

#### The advanced revelations of a simple prefix “**re-**”

The Hebrew word for “**replenish**” found in Genesis 1:28 is defined in all Hebrew lexicons as meaning simply “fill.” The AV translates it as “**replenish,**” pointing to a previous population (Job 38; Psalm 82) who were drowned (II Peter 3:6; Genesis 1:1-2; Psalm 82). Notice: another world that was drowned out before, that God told someone to “replenish.” (Genesis 9:1). Many of the new versions distort this revelation.

The word “**pictures**” in Numbers 33:52 that is one of the main threats to a called out people, who are in danger of picking up the customs and religions of the HEATHEN, doesn’t appear as

“pictures.” Here are some warnings Genesis 3:6; 20:10; Joshua 7:21; II Samuel 11:2. Isn’t this a revelation to twenty-first century Christians that own television sets and laptop computers? The word “**pictures**” is not even in the New KJV.

The advanced revelation of “synagogues” in English over the ‘original’ Hebrew

“**Synagogues**” is definitely an advanced revelation over “meeting places” (Psalms 74:8), especially for the Jews’ enemy. Where would you look for them?

The advanced revelation is an English word not to be found in the ‘original’ Greek

If you didn’t have the word “**churches**,” in Acts 19:37, how would you know that pagans who worshipped the “**queen of heaven**” had them? They already knew that those that worshipped the “queen of heaven” (Jeremiah 44:17) had “temples.” (Ezra 5:14) But, this proves they have CHURCHES. Isn’t this a revelation, especially in light of Acts 12:4? The Greek word in Acts 19:37 is ‘ἱεροσώλους’ meaning “temples.” The King James Bible does something here ‘the Greek’ texts cannot do – fill you in on something that your modern apostate wouldn’t even think of – revelation that exposes the whorish Roman Catholic and Orthodox “**churches**.” Got that?! The King James Bible is anti-Catholic!

The advanced revelation of worldly “**council**” rather than the archaic, dead Greek language

In the Authorized Version the word “**council**” is mentioned 22 times in the New Testament (Matthew 5:22; 12:14; 26:59; Mark 14:55; 15:1; Luke 22:56; John 11:47; Acts 4:15; 5:21, etc.)

The word “**COUNCIL**” in Greek is Sahhedrin (Gr. “συνέδριον”) in every Greek manuscript extant. The Greek language in a dead language with less than 1% of the world’s population that speaks Greek. Therefore the ‘Greek scholars’ would like nothing better than to keep you in the past, historical account of the first century concerning the Jews. But when you talk about the “English” the word “**COUNCIL**” that word by far is more actual. When dealing with world events, we’re not dealing with Synagogues, but with “**COUNCILS**.” It’s in everybody’s vocabulary – There are such councils as

- (1.) Security COUNCIL which is the United Nations.
- (2.) COUNCIL of War
- (3.) COUNCIL for Mutual Economic Assistance
- (4.) COUNCIL of Europe
- (5.) COUNCIL on Foreign Relations
- (6.) Economic and Social COUNCIL
- (7.) COUNCIL for Advancement and Support of Education
- (8.) COUNCIL for Mutual Economic Assistance
- (9.) COUNCIL for Securities Industry
- (10.) COUNCIL for the Encouragement of Music and the Arts
- (11.) COUNCIL of American States in Europe
- (12.) COUNCIL on International Economic Policy

Every time there was a big religions “Council” is was to stop sound doctrine from being published, preached and taught.

That is why the King James Bible is more up to date, because it tells of all the ECUMENICAL church “**COUNCILS**” by religious PHARISEES AND HYPCRITES that have tried to stop and are trying to stop true Biblical Christianity –

- (1.) The National COUNCIL of Christian Churches
- (2.) The COUNCIL of Nicea (325 A.D.)
- (3.) The COUNCIL of Trent (1545-1563) was to counteract the Reformation.

(4.) The COUNCIL of the Vatican (1969-70) was to declare the Infallibility of the Pope.

So if you want to stick to your “Sahhedrin” have at it. You lose!

The object of the Hebrew and Greek Nicolaitanes is to take the “**key of knowledge**” (Lk. 11:52) from you in the name of ‘love’ and strip you from BIBLICAL, King James Bible faith.

The non-existing “Gehenna” vs. the existing “hell”

In the Holy Bible the word “**hell**” is mentioned 23 times in the New Testament. In Greek manuscripts, any of them, the word hell is mentioned only 11 times. Because in Greek manuscripts the word “Gehenna” is mentioned 12 times. The King James translators translated the word “Gehenna” as “**HELL.**”

In these instances the Holy Bible has the upper hand 12 more times than any Greek manuscripts because “Gehenna” means absolutely NOTHING to anyone today.

If that weren’t enough, when you stop and think about these two words, they speak of two different locations. In the Hebrew Bible, Gehenna was initially where some of the kings of Judah sacrificed their children by fire. Gehenna is a small valley in Jerusalem where a fire used to be but HELL STILL EXISTS and will exist throughout eternity.

The Greek word “Gehenna” is *OUT OF DATE*. The King James Bible is *UP TO DATE!*

**ILLUSTRATION** – For instance, what sense would it make for you to preach to a bunch of Roman Catholic priests and say, “**Woe unto you, scribes and Pharisees, hypocrites! for ye compass sea and land [and they do that today] to make one proselyte, [and they do that today] and when he is made, ye make him twofold more the child of GEHENNA than yourselves.**”

Now that would sound really STUPID. Wouldn’t it? What unsaved pagan would understand what “GEHENNA” meant? Go to any person walking around outside and tell him he is going to GEHEHHA! He’d think you were CRAZY!

These dumb stupid Greek “scholars” have no light when it comes to practical matters and correct theology. The translators of the King James Bible were much more practical and sound in their theology.

Here are the following places where the word “**Gehenna**” is used (Matt. 5:22, 29, 30; 10:28; 18:9; 23:15, 33; Mark 9:43, 45, 47; Luke 12:5; James 3:6).

What about the advanced revelations of the punctuation marks in the King James Bible?

There are certain scriptures which are much easier to divide (according to 2 Timothy 2:15) with the use of *punctuation marks*. In the Old Testament, our present Church Age Dispensation was kept secret (cf. Matt. 13:34, 35; Rom. 11:25; Eph. 3:5, etc.). There are remarkable breaks or gaps represented by *punctuation marks*. Like the angels and prophets (1 Pet. 1:11, 12) we may search in vain, while others may refuse to search and “**look into**” these things, and profanely speak of it as simply a “theory.” But we’re not dealing with some kind of “theory.” We are dealing with hard FACTS laid out in plain print. The scripture itself – the King James Bible shows and decides, and the Holy Spirit Himself teaches (Jn. 16:13) while our dear brethren remain ignorant.

For instance, we read of the account of our Blessed Lord what happened in the synagogue at Nazareth,

“And there was delivered unto him the book of the prophet Esaias. And when he had opened the book, he found the place where it was written,

The Spirit of the Lord *is* upon me, because he hath anointed me to preach the gospel to the poor; he hath sent me to heal the brokenhearted, to preach deliverance to the captives, and recovering of sight to the blind, to set at liberty them that are bruised,

To preach the acceptable year of the Lord.

And he closed the book, and he gave *it* again to the minister, and sat down. And the eyes of all them that were in the synagogue were fastened on him.” (Luke 4:17-20)

Why this mysterious action? Why not continue the reading? Because He could not; for the words which immediately follow refer to the end of this present Dispensation of Grace, (the Church Age – the body of Christ) and speak of the coming Dispensation of Judgment during the time of the Great Tribulation called “**the time of Jacob’s trouble**” (Jer. 30:7) dealing again with the nation Israel (not the body of Christ) as it was in the Old Testament. Had he continued to read Isaiah 61:1, 2, the next line would have been, “**And the day of vengeance of our God**”. But this part of the prophecy was not then to be fulfilled at the time when He ministered while on the earth. As far as He had read, He could truly say, “**...unto them, This day is this scripture fulfilled in your ears**” (v. 21). But He could not have said, “This day is this Scripture fulfilled,” had He not “closed the book” but gone on to read the next line. And yet, in the King James Bible there is only a *comma* between the two lines, while there is a period of nearly 2,000 years between the two statements. THAT you will NOT find in the manuscripts for there are no marks of punctuation at all.

So the King James Bible is **ADVANCED** in the manner of punctuation marks that ‘out do’ the ‘original’ Hebrew and the ‘original’ Greek. You can find this same kind of *advanced revelation* in –

Genesis 1 between verses 1 and 2,  
Isaiah 9:6 after the first clause,  
Zechariah 9 between verses 9 and 10,  
Luke 1 between verses 31 and 32,  
1 Peter 1 in the middles of verse 11.

The list goes on and on.

Because of the lack of knowledge (Hos. 4:6) concerning God sealing these advanced revelations in the perfect Bible, that is based on the perfect, international language for the whole world, our brethren are simply ignorant (1 Cor. 14:38).

Just as God the Father “**approved**” Jesus Christ (Acts 2:22) and was **sealed** by the Father (John 6:27) so also God has “**approved**” of His very words by using a saved King (James) the authority, to authorize the translation of the King James Bible. It is just as much “**sealed**” as the born-again believer is “**SEALED**,”

“**Who hath also sealed us**, and given the earnest of the Spirit in our hearts,” (2 Cor.1:22)

“And grieve not the holy Spirit of God, whereby ye are **sealed unto the day of redemption**,” (Eph.4:30).

That is why the corrupt versions are rampant, - NO UNDERSTANDING!

“My people are destroyed for **lack of knowledge**: because thou hast **rejected knowledge, I will also reject thee**, that thou shalt be no priest to me: seeing thou hast forgotten the law of thy God, I will also forget thy children” (Hos. 4:6; 6:6).

Step no. 6

*The decree is translated from the original of that king into another language* (Esther 1:22). Specifically in the book of Esther there are three universal decrees (chapter 1; 3:12-15; 8:9-14). Each of these decrees was translated into the languages of 127 provinces; anywhere from 127 to 365 different languages. The question arises: “Were any of the translations any less the decree of the king simply because they were not in the original Persian? Of course not! Now, if that’s the case with the words of an earthly king, why would the words of the Holy Spirit be any different? Is there anyone naïve enough to believe that the God who preserves everything, **“And he is before all things, and by him all things consist,”** (Col.1:17) was unable to preserve His words in more than three languages (Hebrew, Aramaic and Greek)?

Note that the writing would have to be translated and published according to the languages of those living in other provinces where there could have been a total of over 365 different languages. That’s all from one ORIGINAL language from a KING.

Now do you see the point? Since it was a Gentile King, Cyrus that gave the Jews permission to return back to their homeland, that Gentile King would match England as we clearly stated earlier for it was King George of England that granted the Jews back to their land. It was a KING, James that authorized the translation of the King James Bible and to be read all across his KINGDOM.

Those very words are to be translated into as many languages as possible in the realm of that King in all his provinces v. 1 (See also Dan. 5:31-6:1) 1:1, 3, 16, 22; 2:3, 18; 3:18, 12, 13, 14; 4:7, 11; 8:5, 9, 11, 12, 17; 9:2-4, 12, 16, 20, 28, 30.

The decree was to be TRANSLATED for **“every people, nation, and language.”** (Esther 1:22; 3:12; 8:9).

That means those very words from the king would be translated to know *exactly* what the king said.

The *APPLICATION* is obvious. The King, James who authorized the translation gave word for it to be published throughout his kingdom. Not only that. Those very words should be reproduced in other languages in other nations – meaning world-wide.

Now getting back to the book of Esther. That document has authority from the King. Then Esther the queen, the daughter of Abihail, and Mordecai the Jew, **wrote with all AUTHORITY**, to confirm this second letter of Purim. (Esth. 9:29).

Here we see certain events taking place in the history of the Jewish people because of the authority given to Esther and Mordecai. They received their authority from the King.

*APPLICATION:* That is the case for any child of God. **“But as many as received him, to them gave he power to become the sons of God, even to them that believe on his NAME:”**

When the child of God has been given kingly power, God’s power and God’s words, and when we say God’s words we’re dealing with one book, a ‘kingly’ book – the King James Bible, even when he WRITES it will carry a lot of weight and AUTHORITY, no matter who accepts that or not –

“Then Esther the queen, the daughter of Abihail, and Mordecai the Jew, **wrote with all authority**, to confirm this second letter of Purim” (Esth.9:29).

This is the first time where the word **“authority”** is mentioned in the scripture. It must have some significance. Let’s take a closer look.

Notice that the authority was given **“to confirm”** something **“...this second letter...”**

The former letter is mentioned in 9:20, did only recommend but this enjoins the observation of this solemnity of Purim: because this was not only Mordecai’s act, but the act of all the Jews, binding themselves and posterity and to stir up devout affections in the minds of its readers. Note that the festival was appointed by AUTHORITY, yet under the direction of the power of the King. It was the result of the Divine Providence of God Almighty. It was called the feast of Purim. The name of this festival would remind them of the Almighty power of the God of Israel.

Notice how this “authority” was not abused but used for the sake of peace and truth throughout kingdom (v. 30)

“And he sent the letters unto all the Jews, to the hundred twenty and seven provinces of the kingdom of Ahasuerus, *with words of peace and truth,*”

It was a letter of confirmation concerning the decree of Purim, the Jewish holiday (Esth.9:32). Mordecai displayed the perfect attitude of a public servant (Prov. 29:2).

“When the **righteous are in authority**, the people **rejoice**: but when the wicked beareth rule, the people mourn.”

Mordecai was “advanced” by the “power” and “might” of king Ahasuerus (10:2). He was next unto the king, great among the Jews and accepted among his brethren (10:3). His lawful policies were for the benefit and wealth of the people rather than himself (1 Cor. 10:24); Phil. 2:3, 4).

He is an example of a truth bearer!

*APPLICATION:* There had been other translations prior to the King James Bible that had weight; Tyndale’s New Testament, Coverdale’s Bible, Great Bible, Bishop’ Bible, Geneva Bible, etc. But it would be one and final Bible that would be used in a much greater way, SANCTIONED by King James. The very Holy Spirit would sanction that text and give His subjects the authority to carry out what deems Him fit for His own glory and honour. That is exactly what creates UNITY among the King’s subject. If that ‘system’ of ‘governmental power’ is rejected at that point disunity is created.

Anybody that has been trained in spiritual matters most certainly can tell the difference between the preaching of a non-denominational preacher like John MacArthur who preaches from a false ‘bible’ and the preaching of some unlearned, country preacher who may not be all that educated, that is, taught in a ‘Christian’ college or seminary who preaches from the King James Bible. It is like night and day.

That brings us to the final and seventh step, the step of *perfection* –

#### Step no. 7

The last step for the word of the king to be known in other languages is that it must be **“published.”**

We read also in Esther 8:9, 10 –

“Then were the king’s scribes called at that time in the third month, that *is*, the month Sivan, on the three and twentieth *day* thereof; and it was written according to all that Mordecai commanded unto the Jews, and to the lieutenants, and the deputies and rulers of the provinces which *are* from India unto Ethiopia, an hundred twenty and seven provinces, **unto every province according to the writing thereof, and unto every people after their language, and to the Jews according to their writing, and according to their language.**

And he wrote in the king **Ahasuerus’ name**, and sealed *it* with the king’s ring, and sent letters by posts on horseback, *and* riders on mules, camels, *and* young dromedaries:”

That’s how it is to be published, not only in the ‘original’ language was the decree to be published. Now note that word “**published**” (Esther 1:22). That would be the *seventh step* in this all important subject concerning translating the King James Bible (and not any Hebrew and Greek texts) into other languages.

“And when the king’s decree which he shall make shall be **published** throughout all his empire, (for it is great,) all the wives shall give to their husbands honour, both to great and small,” (Esth. 1:20).

“For he sent letters into all the king’s provinces, into every province according to the writing thereof, and to every people after their language, that every man should bear rule in his own house, and that *it* should be **published** according to the language of every people,”

(Esth.1:22).

“The copy of the writing for a commandment to be given in every province was **published** unto all people, that they should be ready against that day,” (Esth.3:14).

Look at the urgency of getting the decree of the king out *into as many languages as possible and also PUBLISHED*. There must be an ongoing of those words of a king and the *printing* of it also.

Here we see the advantage of the English language, the foundational language of the King James Bible for the word “**publish**” has more than just one meaning. The word carries the thought of proclaiming, preaching and teaching. But in another sense the words of the king can be *printed* – published. You have various publishers, companies that print the living words of the Living God, etc. You can print out a tract and “publish” the words of God. Now you have the advantage of mass media to “publish” the printed word through internet, youtube, etc.

Look at this verse, “The Lord gave the word: **great was the company of those that published it,**” (Psa.68:11). The verse can be applied both ways and still make very much sense.

#### One more little, BIG detail

Before the text can be **published** there is one more seemingly little detail that makes a big difference in understanding this all-important issue of a decree of a king that was to be signed, sealed and delivered. The only problem is if it were to be translated and delivered there would have to be copies for everyone to go around. Oh yes, the copying. What an all-important subject! For what we learn about a decree of a king is to be directly applied to matters of the final authority – the King James Bible and the putting together the Bible itself over a period of over 1500 years.

When the Bible talks about “**scripture**” mentioned 32 times or “**scriptures**” mentioned 21 times, not one time does the Holy Bible imply anything about ‘*the originals.*’ It’s not there. For any Nicolaitan, i.e. a Hebrew or Greek ‘scholar’ to think that ‘the Bible’ was put together with originals



is absolutely absurd, for the word “Bible” means ‘the Book’ which consists of 66 books put together in ONE BOOK. That had never taken place until after John around 95 A.D. finished writing the sixty-sixth book – Revelation. Question. How in the world could John possess in his hands ‘the originals’ of all sixty-five other books of the Bible? Unless he had a “COPY” and or a copy of a copy of a copy of a copy that was passed on to him that the Lord PRESERVED. But then again the apostle Paul would have reminded John that “**For we are not as many, which corrupt the word of God...**” (2 Cor. 2:17). So, John would have had to know which readings in a set of copies had the right readings in them and which didn’t, just like it is necessary to know TODAY which reading in any given ‘bible’ is true and which reading in any given ‘bible’ is false. That’s why you would need ONE FOUNDATIONAL STANDARD, THE FINAL AUTHORITY BY WHICH TO JUDGE ANY AND ALL READINGS IN ANY VERSION. There can’t be TWO final authorities unless you were a Hebrew and Greek ‘scholar,’ who would, of course make HIMSELF, the final authority and deceive you into thinking that he is your authority.

Let’s take another look at the Book and what God has to say about “copies” –

“And it shall be, when he sitteth upon the throne of his kingdom, that he shall write him a **copy of this law in a book** out of *that which is* before the priests the Levites:” (Deut. 17:18).

At first sight it doesn’t seem like there is much to this verse but taking a closer look at this verse you have the following facts –

1. There was already something available for which the king to make a copy. Something had to be PRESERVED, “**out of that which IS...**” There is the key of preservation, copying from “**this law...**” implying it was already available.

2. It is a copy “out of that which *IS* before the priests the Levites.” Again we find that dastardly word “**IS**” which drives the Alexandrian cult leaders, the Nicolaitans, the “**Yea, hath God said,**” Society” nuts! For they are reminded in the King James Bible that “All *scripture IS GIVEN* (present tense) *by inspiration of God, and IS profitable* (present tense) *for doctrine, for reproof, for correction, for instruction in righteousness:*” (2 Tim. 3:16) which means that, “*there IS* (present tense) a spirit in man: and the inspiration of the Almighty **GIVETH** (present tense, 2019) them understanding,” (Job 32:8). So that when you get understanding of what God says, at that moment “**INSPIRATION**” takes place, for it is of the SPIRIT of God. That is where proper translation takes place and those words become “**scripture**” or “**scriptures.**” And since ‘originals’ do not exist nor is the word mentioned at all in scripture, therefore a translation and copies where there has been a faithful translation and a faithful copy takes place you then have a “**faithful witness**” thus producing “**scripture.**” *THAT* is what “**cannot be broken**” according to Jesus Christ (Jn. 10:35), “If he called them gods, unto whom the WORD OF GOD CAME, and **the scripture cannot be broken;**”

Notice that “**THE word of God**” is “**THE SCRIPTURE**” - one complete, unmarred, volume of the pure words of God in any copy of any translation in any language with the witness as a faithful transmission –

“**A faithful witness** will not lie: but a false witness will utter lies,” (Prov.14:5).

“And from Jesus Christ, *WHO IS* (present tense) **THE FAITHFUL WITNESS**, and the first begotten of the dead, and the prince of the kings of the earth... (Rev.1:5).

Notice that Jesus Christ “**IS**” (in *italics* and present tense) Who has His word, which “**IS**” (in *italics*, present tense) THE representative of THE Word, (Jesus Christ). That’s what He accomplished through His word on this earth. Thus “**the word of God**” consists of “**WORDS**” of God” (Deut. 32:44-46) and those words are preserved, with the proper translation, in advanced form,

sanctioned by a king, (James) who's kingdom was a world power, whose words are preserved in the King James Bible and translated into other languages. THAT is the proper and *only way* from which any other Bible ought to be translated. The act of transmission is laid out in the King James Bible by the words of a decree of a king.

Jesus Christ said, "...I am **THE WAY**, the truth, and the life: no man cometh unto the Father, but by me."

*APPLICATION:* There is only ONE WAY to get to heaven. Jesus said, "I am **THE Light** of the world." There is only One True King – King Jesus! There is only one true WAY for translating the Bible into another language – from One True 'King' Book! That's what would make 'life' a whole lot simpler for translators around the whole world for the 'light of the world' for the sake of unity in the body of Christ.

So getting back to a "**copy**," let's take another look at that word, "And he **wrote there upon the stones a copy of the law** of Moses, which he wrote in the presence of the children of Israel," (Josh. 8:32).

Here we find Joshua writing a "**COPY**" of the law of Moses. So now there would be at least TWO sets of '**scripture**;' one from which Moses would have written, if there hadn't been already at least one or two of them PLUS that which Joshua wrote.

This is the key to publishing the words of God; by making copies. The more the better. The more that people get the word of God, the more will read it, the more folks get saved and the more God gets the glory.

You see, if there was no copying going on, then a whole lot less people would be able to hear the words of God. That would hinder the work of God; thus less people would hear the words of God. Then more people would go to hell. Then, the more Satan would be satisfied.

So this NONSENSE that various people would have to have the 'originals' to translate from and for that matter preach from is absolutely childish. It limits God beyond our imagination.

"Yea, they turned back and tempted God, and limited the Holy One of Israel." (Psa. 78:41)

We come to the instance where a copy would be sent to another land –

"This *IS* (italics, present tense) the **COPY OF THE LETTER** that they sent unto him, *even* unto Artaxerxes the king; Thy servants the men on this side the river, and at such a time," (Ezra 4:11).

Here it is plain as day that a "**copy**" is a duplicate which is just as important as the 'original.' To think, as the modern apostates that a translation cannot be as good as the 'originals' is absolutely absurd. If that weren't enough the writing of the letter was "**in the Syrian tongue**," (v. 7). That means that the slanderous letter was originally written in the Syrian tongue, but it was recorded in the Hebrew language of the '*original autographs*.' This would make the TRANSLATION "**given by inspiration of God**" (Acts 21:40). But that is simply too much sound doctrine that our weak brethren simply cannot handle (2 Tim. 4:3) –

"For the time will come when **they will not endure sound doctrine**; but after their own lusts shall they heap to themselves **teachers**, having itching ears;"

*APPLICATION:* If any man would make any attempt to discredit God's method of preserving His words by lying, saying that a translation cannot be inspired, then you would do well to recognize this

man's immaturity for he is causing division in the body of Christ. He is hindered in his growth and he is trying to hinder your growth of understanding what the Holy Spirit has laid out concerning COPIES of God's words. He is **"dull of hearing"** (Heb. 5:11) and you are to mark that man –

"Now I beseech you, brethren, mark them **which cause divisions and offences contrary** to the doctrine which ye have learned; and avoid them." (Rom. 16:17)

Let's move on with this very simple word **"copy"** –

"The **copy** of the writing for a commandment to be given in every province *was* published unto all people, and that the Jews should be ready against that day to avenge themselves on their enemies," (Esther 8:13).

Here we find the combination of the word **"copy"** NOT 'the originals' and **"published unto all people"** meaning TRANSLATIONS. That is what 'ties the rag on the bush' for the Nicolaitanes. They can't stand the fact that God would use COPIES and not 'the originals' for his words to be preserved (Psa. 12:6, 7) even in TRANSLATIONS which will be discussed next.

Finally, concerning this all important little, BIG detail, how could it be that folks like Ezra, Nehemiah, and others would have access to the words of God, and how could they know what was written? Well, that is quite simple to answer. About five centuries before that, approximately 1000 B.C. God would have the following penned,

"These **ARE** (notice the *italics*, present tense. Remember 2 Timothy 3:16, "All scripture **IS**...") also **proverbs of Solomon**, which the **men** of Hezekiah king of Judah **COPIED** (past tense) **OUT**," (Prov.25:1).

"Horrors" say the Hebrew and Greek scholars." "Oh my God!" says the Alexandrians along with *'the Textus Recptus'* ('TR') men.

If that isn't enough for the apostate brethren to get right, then nothing else will. They are too far gone.

The scribes of Hezekiah were part of the preservation of God's word. The King James Bible was translated not by just one or two men, but over fifty of them, **"the men"** under a King, James, just like **"the men of Hezekiah king of Judah copied out."** The true words of God today in the international language for the whole world are preserved through copies of copies of copies (Jer. 36:27-32).

Now we can look into the issue of translations.

#### A MORE DETAILED LOOK AT A TRANSLATION

In this section we want to take a very careful look at the approach to translating the Bible into a foreign language. All of the linguistic schools pass up *the Biblical method* as to how to make a translation. Much time, energy, paper and MONEY are spent trying to translate the Bible into a foreign language when almost all of them 'missed the boat' to say the least. They missed the *revelation* laid out in the very book that not only mentions the word **"translation"** but also gives you the various and yet *detailed elements* that make up the definition of the word **"translation."** Since this *revelation* has been passed up for nearly 4 centuries (since the publishing of the King James Bible) by all of your 'linguistic schools', churches and missionaries, then *that will be the reason why*

*there is an ongoing battle between Bible believers and Fundamentalists and or Evangelicals on the foreign fields who can never come to terms of the “common faith” (Tit.1:4). There won’t be any unity (Psal. 133:1; Eph. 4:3, 13) until they have the same Biblical FAITH. So if the missionaries are to have Biblical faith then they’ve got to settle the issue of WHICH BIBLE. And until they’ve got that settle there won’t be “THE (singular) unity of THE (singular) Spirit,” (Eph. 4:3), nor “THE (singular) unity of THE (singular) faith” (Eph. 4:13). As a result you have duel bibles, duel authorities, duel spirits and duel faiths. That causes unbiblical DIVISIONS.*

Now in the ‘economy’ of God (that’s what the new-evangelicals like to hear, “economy”) we’re talking about how God uses His own words to define His own book by His own system outlined, explained and detailed by His own WORDS (plural). You would be breaking the law of God’s system and ‘government’ when you take ‘laws’ from another system outside the law of God’s book and cram them into God’s system of laws and words; laws that make up God’s words and words that make up God’s laws. Too hard to swallow huh?

We are about to embark on is an excursion Who’s Leader and Guide is the supernatural ‘Guide’ of the Holy Spirit. He’s never steered anyone the wrong way but many are not satisfied with His job so they, of course try to be their own ‘guide.’ His course is sure and will lead you into many very interesting ‘sites’ (Jn. 16:13).

### **Five-fold Definition of a Biblical Translation**

Concerning this all-important subject of a translation being inspired we’ve covered the ground concerning the King James Bible. Next the task of translating the Bible into a foreign language, we’ve already established you must have the *right basis and power of authority*. When a decree was made by a king, that decree was committed to writing, signed, sealed and delivered “**published.**” The subjects of the king in the Old Testament would get their “promotion” only when they were in subjection to the king’s power and authority. Ezra Nehemiah, Esther and Daniel were blessed of God because they were subject unto the king’s under whom they served. That is the foundation? To further explain this it is absolutely necessary to see the importance of the translation of the King James Bible as THE basis for modern translations of the Bible in foreign tongues that ought to be subject to that translation since it was authorized by a king. Unfortunately our weak kneed brethren back pedaled to the “originals” simply because they couldn’t handle the heat of those that wouldn’t believe that a translation (the King James Bible) could be the infallible, preserved, inspired word of God. Then when they professed that the “Word’ of God was in a Textus Receptus that failed too because then they got heat from those saying that there are various Textus Receptus’ and they all say something different so BACK to the ‘originals’ WHICH NOBODY HAS. They stumbled over “**All scripture IS given by inspiration of God, and IS profitable for doctrine, for reproof, for correction, for instruction in righteousness:**” (2 Tim. 3:16). That’s what drives the scholars crazy especially when the word “*is*” is in italics two times defining *present tense inspiration* and not only PAST tense – subjecting a Bible to manuscripts that *WERE* inspired but not to “*IS*” which speaks of a translation – AUTHORIZED BY A KING.

For us to get the principle of translating the King James Bible into a foreign tongue it is necessary to see what the Bible itself says about the word “translation.” There are three instances in the Bible where *some thing* or *somebody* was translated. In chronological order we find first of all –

Enoch was *translated* from earth to heaven, for in Genesis 5:24 we read,  
“And Enoch walked with God: and he *was* not; for God **took him.**”

That is explained in Hebrews 11:5 where the word “translated” is mentioned 3 times –

“By faith Enoch was **translated** that he should not see death; and was not found, because God had **translated** him: for before his **translation** he had this testimony, that he pleased God.”

In this single verse we find two forms of the word – “**translated**” and “**translation.**” The other two times the word is mentioned has to do with a kingdom.

The second time we find the word “**translate**” mentioned is in 2 Samuel 10:13. Here the Lord translated the Kingdom of Saul to the Kingdom of David.

The third time a translation takes place has to do with the believer in Christ who at the moment of the new birth is “**translated ...into the kingdom of his dear Son:**” (Col. 1:13).

In all three cases there are five principles in which determine the absolute rule for a proper translation to take place –

1. The LORD inspires the translation (Job 32:8; 2 Tim. 3:15, 16).

There are only two places in the entire Bible where the word “**inspiration**” is mentioned (Job 32:8 and 2 Tim. 3:16).

2. Man is involved in the translation, an interpreter (Moses, David, Paul, and Jesus Christ).
3. The translation, or the word is eternal.
4. The word is flawless; however, it may not match the original.
5. The translation is better than the original. (We will explain that.)

Now in each of the cases of translation as we break them down more definitely we find a five-fold definition of a translation so that there can be no doubt as to why the King James Bible is not only the absolute, infallible word of God but it is also THE words of a King, King Jesus, written by the Holy Ghost, preserved in the international language of English for all the rest of the world to know what God said. Therefore a translation of the King James Bible must take place for foreigners also to know what God said. That is the only and proper approach to translating the words of God into a foreign tongue, just as the decrees of Cyrus, Darius, etc. were to be translated and published all across their kingdoms in various languages and provinces.

#### First Definition

*First it is THE LORD that inspires a translation.*

“And Enoch walked with God: and he *was* not; **for God took him.**”

Nobody but God could do that, that is, translate Enoch. The LORD inspires the translation (Job 32:8; 2 Tim. 3:15, 16).

*Secondly, Man is involved in the translation*

Enoch was involved in the translation for *he himself* was the one translated. Man is involved in the translation (Moses, David, Paul, and Jesus Christ).

*Thirdly, the word is eternal.*

What God did cannot be changed. He fixed it so that Enoch could not go to hell. He went directly to heaven.

*Fourthly, the translation was flawless; however, it may not match the original.*

What God did was *perfect*. Nobody, even Enoch could complain that God did not ‘do a good job.’ It was efficient! Enoch was translated to heaven. To think that Enoch was better off on this earth than his condition right now in heaven is simply foolish.

And that leads us to the fifth and final definition of a translation.

And *fifthly, the translation is better than the original.*

It is obvious that Enoch’s condition now is far better than his original state before he was translated. The apostle Paul said, “For I am in a strait betwixt two, having a desire to depart, and to be with Christ; **which is far better:**” (Phil. 1:23). So Enoch is better off now than when he was on this earth.

So there you have it, a *translation* that is **BETTER** than what was before.

Let’s move on to the second occasion where a translation took place, in 2 Samuel 10:13 and see these five different aspects of a translation again.

**“To translate the kingdom from the house of Saul, and to set up the throne of David over Israel and over Judah, from Dan even to Beersheba.”**

What a discovery! What a revelation! What a ‘site’! The law of first mention establishes the definition for the word **“translate.”** Now if there were any doubt as to the quality of the first kingdom compared to the second, our Guide will lead us to the proper facts concerning this historical monument concerning the word **“translate.”** Listen carefully –

“And Samuel said unto him, **The LORD** hath rent the kingdom of Israel from thee this day, and **hath given it to** a neighbour of thine, **that is BETTER than thou,**” (1 Sam. 15:28).

In short the quality of the kingdom would depend on the quality of the King. David was “better” than Saul, according to the Holy Spirit.

Who could doubt the leadership of King David? Was it not better than what Saul did? Of course. That means that the TRANSLATION of the kingdom was for the betterment of Israel.

So the matter of translation was God’s doing. It is God that **INSPIRED THE TRANSLATION** –

“For promotion *cometh* neither from the east, nor from the west, nor from the south. **But God is the judge: he putteth down one, and setteth up another,**” (Psa.75:6, 7).

God was the Director in putting down Saul and TRANSLATING the kingdom to David!

**APPLICATION:** God saw in His providence to put down now the Hebrew and Greek after the TRANSLATION of the King James Bible. The TRANSLATION was *for the betterment* of His people. That translation **“IS”** (PRESENT TENSE) the breath of God (Job 32:8), the **“inspiration”** FOR THE WHOLE WORLD FROM WHICH TO TRANSLATE OTHER LANGUAGES! That principle we learned already from the books Ezra, Nehemiah, Esther and Daniel. Four different writers give you that revelation. What more do you want?

*First*, we learn first that the Lord inspires the translation (Job 32:8; 2 Tim. 3:15, 16).

*Secondly* we learn that man is involved in the translation.

Concerning the translation of the kingdom of Saul to David, God was not pleased in the way Saul ran things so He had to pick somebody else, David. David was involved in the translation for God "... [translated] the kingdom from the house of Saul, and...set up the throne of David over Israel and over Judah, from Dan even to Beersheba."

"And Samuel said unto him, The LORD hath rent the kingdom of Israel from thee this day, and hath given it to a neighbour of thine, *that is BETTER than thou,*" (1 Sam. 15:28).

Throughout the history of the Church Age, and even before that *men were always inspired by God and used them to translate* –

1.) All conversations between Moses and Pharaoh, in the Egyptian language (Exodus 5-11), were translated by Moses into "original manuscripts" into Hebrew.

2.) All the decrees of Artaxerxes and Darius were *translations*, as were the decrees of Nebuchadnezzar (Dan. 3:29; 6:25; Esther 8: 8-13).

3.) All languages in Acts 2 were *translated* directly "inspired by God" through the Holy Spirit (Acts 2:6-11).

4.) More than 40 verses in the "original manuscripts" of the new covenant were Greek translations from the Hebrew (Matt. 1:22; 2: 5, 17; 4:15; 9:13; 11:10; 12:18).

5.) The Old Testament original manuscripts were written in Hebrew; New Testament "original manuscripts" were written in Greek. These original Greek manuscripts were *TRANSLATIONS* from Hebrew: (Matthew 8:17; 9:13; 11:10; 15: 7; 19: 4; 21:42; 22:44).

6.) The term "**scripture**" in the scriptures is never a reference to any "*original manuscripts*" of Isaiah 800 BC. The "**scripture**" to which Christ speaks in Luke 4:21 were copies of copies. He had no "original" from the book of Isaiah (61:2).

7.) The "Scripture" that Phillip and the eunuch read (Acts 8:35) was not the "original manuscript" of Isaiah but was "**given by [God's] inspiration**" (2 Tim. 3:16).

8.) The apostle Paul had to translate that which was originally written in Hebrew. Paul would quote often Old Testament Jews who spake in Hebrew. Any quotations found in Paul's epistles that are from the Old Testament may not be a word for word quotation. That is what you call "inspiration" in a translation.

So to think that the King James Bible is 'only' a translation you'd better stop and reconsider the practice of God in His book these facts about a translation –

1. A translation can be and **IS** inspired (Job 32:8; 2 Tim. 3:16) for we read –

"And when he had given him license, Paul stood on the stairs, and beckoned with the hand unto the people. And when there was made a great silence, **he spake unto them in the Hebrew tongue**, saying...And when they heard that he spake in the Hebrew tongue to them, they kept the more silence: and he saith,) (Acts 21:40, 22:2).

Paul's testimony was originally spoken in Hebrew, but it was recorded by Luke in Greek. The scholars will piously boast of the inspiration of Acts 22 in the originals; therefore, Paul's defense as recorded originally was an *inspired translation* (See Ezra 4:7.). The scholars will also adamantly scoff at the claim of the preserved inspiration of the words in the King James Bible, yet they worship the unseen Greek translation of the Old Testament, the Septuagint. At heart they are hypocrites.

*Thirdly, the translation, or the word is eternal.*

David's kingdom is eternal. What God did cannot be changed.

“And thine house and thy kingdom **shall be established for ever before thee: thy throne shall be established for ever**” (2 Sam. 7:16).

What God did would ‘fix’ or establish what God intended. David’s throne and kingdom would be an everlasting kingdom, exemplified in Solomon’s reign as a type of Jesus Christ but in its purest form would eventually be realized by Jesus Christ and His reign on the throne of David.

“And king Solomon *shall be* blessed, and the throne of David shall be established before the LORD for ever.”

“And thine house and thy kingdom shall be established for ever before thee: thy throne shall be established for ever,” (2 Sam. 7:16).

Of course all of this is to be realized by the “**KING OF KINGS AND LORD OF LORDS**” (Rev. 19:16) upon His return at the Second Advent.

When that translation had been made it is also “**given by inspiration**” and therefore ETERNAL, POWERFUL, “**SCRIPTURE**” AND INSPIRED!

*Fourthly*, the translation was flawless; however, it may not match the original.

The Lord did not make a mistake when he “... [**translated**] **the kingdom from the house of Saul, and to set up the throne of David...**” for it was God Himself that did the translating –

“But now thy kingdom shall not continue: **the LORD hath sought him a man after his own heart, and the LORD hath commanded him to be captain over his people, because thou hast not kept that which the LORD commanded thee,**” (1 Sam. 13:14).

And Luke adds to the revelation concerning this historical translation recording what the apostle Paul preached in Antioch of Pisidia –

“And when he had removed him, he raised up unto them David to be their king; to whom also he gave testimony, and said, I have found David the *son* of Jesse, **a man after mine own heart, which shall fulfil all my will,**” (Acts 13:22).

*Fourthly, the translation is eternal, flawless;* however, it is a TRANSLATION and it may not match the original.

David’s kingdom is in type the reign and kingdom of our Lord Jesus Christ. Not only that. You find many times that the Lord compared all the rest of the kings after King David for David was a type of Jesus Christ.

“**And if thou wilt walk before me, as David thy father walked, in integrity of heart...**”  
(1 Ki. 9:4).

“And it shall be, if thou wilt hearken unto all that I command thee, and wilt walk in my ways, and do *that is* right in my sight, to keep my statutes and my commandments, **as David my servant did,**” (1 Ki. 11:38).

Quotations of the Old Testament in the New Testament meet the requirements for a text, translation to be inspired, thus flawless. For example, Habakkuk said,

“Behold, his soul *which* is lifted up is not upright in him: but the just shall live by **his faith,**”  
(Hab. 2:4)



The apostle Paul quotes that text with a slight variation, “For therein is the righteousness of God revealed from faith to faith: as it is written, **The just shall live by faith,**” (Rom. 1:17), and repeats that in Galatians 3:11 and once more in Hebrews 10:38. Concerning Hebrews 10:38, an honest and discerning Bible student observes the postscript after the inspired quotation and translation of Habakkuk 2:4. Paul’s quotation for the Body of Christ does not include this postscript for the Hebrews of the Tribulation, “**but if any man draw back, my soul shall have no pleasure in him**” (Rom. 1:17; Gal. 3:11). Spiritual discernment aids the faithful student to understand the doctrinal differences throughout the Scriptures (1 Cor. 2:9-16; 2 Tim. 2:15).

The word “**his**” had been deleted from the “originals” (Hebrew) in the other “originals” (Greek) which is the proper translation. So therefore the ‘original’ Greek, although it is a *translation* from the Hebrew text is still inspired and flawless.

The translation in the New Testament is better in the sense that now a sinner is saved by the faith of Christ and not by “his faith” as in Habakkuk for we read in Galatians 2:16

“Knowing that a man is not justified by the works of the law, but by the faith of Jesus Christ, even we have believed in Jesus Christ, that we might be justified by the **faith of Christ**, and not by the works of the law: for by the works of the law shall no flesh be justified.” That salvation is flawless. The translation which if it is “**given by inspiration**” is of God and technically is then “**scripture**” then it is flawless.

And *fifthly, the translation is better than the original.*

David’s kingdom was *better* than Saul’s kingdom. God *authorized* the translation. The proof of that is the Lord Jesus will sit upon David’s throne (Luke 1:30-33) and not on Saul’s. That’s how much God honored David!

So there you have it, a translation that is *BETTER* than what was before.

The *third event* that takes place in the Bible concerning a translation is when a sinner trusts the Lord Jesus Christ as his personal Saviour,

“Who hath delivered us from the power of darkness, and hath **translated** *us* into the kingdom of his dear Son:” (Col. 1:13).

Again all five requirements of a proper translation take place –

1. The Lord inspires the translation. He’s the author of the *translation* by the word of God and by the Spirit of God.

2. Man is involved in the translation. If you are saved, then *you* were translated.

3. The word is eternal. If you’ve been translated, then that cannot be changed. It is an *eternal translation*.

4. The translation is flawless. What Jesus did was perfect.

5. The translation is better than the ‘originals.’ When you were saved, God translated you and your condition judicially before God Almighty is *far better* than your previous condition as a lost, hell-bound sinner.

In all three cases of a translation spoken of in the Bible; (Enoch – a physical translation; a translation of a kingdom and a spiritual translation of the soul of a sinner), you see without any shadow of doubt that the condition of Enoch (Gen. 5:24; Heb. 11:5), or the kingdom of David (2

Sam. 3:10) or the believer in Jesus Christ after his translation (Col. 1:13) is far better than its previous condition, before the translation.

*APPLICATION:* The AUTHORIZED KING JAMES BIBLE meets the fivefold definition of a translation –

1. *The LORD inspired the translation* (Job 32:8; 2 Tim. 3:15, 16).

There are only two places in the entire Bible where the word “inspiration” are mentioned (Job 32:8 and 2 Tim. 3:16).

The word “inspiration” is clearly defined by its only other occurrence in the Bible. The usage of the word reveals its definition. Job 32:8 says, “**But there is a spirit in man: and the inspiration of the Almighty giveth them understanding.**” Noah Webster got the Scriptural definition right on the third definition of the 1828 American Dictionary of the English Language. The pure King James Bible defines inspiration to mean the infusion of ideas into the mind by the Holy Ghost (John 16:13). This is why all scripture IS given by inspiration of God (2 Timothy 3:15-17). It is present tense. Brother Schaap and company limited inspiration to the past originals. Preservation without inspiration is pointless. Fruit that is not preserved in its natural state is of little or no value. The fruit of the words of God is preserved with its in-**spir**-ation in the King James Bible.

Understanding of the truths of the pure Scriptures IS given by the inspiration of God today and IS profitable for doctrine, for reproof, for correction, for instruction in righteousness today. The giving of understanding to the spirit of the believer is through the Spirit of God (Romans 8:16). Is this too simple? Any humble child can believe and understand that the Author of Scripture is the Interpreter of the words of Scripture (Genesis 40:8; 1 Corinthians 2:9-16).

“**For God so loved the world, that he gave his only begotten Son, that whosoever believeth in him should not perish, but have everlasting life.**” The Son is given to the sincere believer today. The same is true for the written word of God. Understanding of the Scriptures is given to the sincere believer without the scholarship of the original languages.

When Phil Pins (from Hyles-Anderson College) revealed his wonderful knowledge of the Greek language and his scholarly explanation of 2 Timothy 3:16, he subtly implied the phrase “is given” was referring to the originals in the past; however, said phrase is also in the great commission that is available to Brother Pins today while he wisely wins souls today.

1 Peter 5:1-4 reveals the opportunity to receive a crown of glory to the faithful shepherd who feeds the word of God to his people. There is a vital condition upon receiving the crown of glory in Proverbs 4:7-9. The crown of glory is only given to the faithful shepherd who gives glory and honour to whom it is due. Proverbs 4:7-9 says,

“Wisdom is the principal thing; therefore get wisdom: and with all thy getting get understanding. **Exalt her**, and she shall promote thee: she shall bring thee to honour, when thou dost embrace her. She shall give to thine head an ornament of grace: a crown of glory shall she deliver to thee.”

The crown of glory will be given to the shepherd who glorified the wisdom and understanding of the words of God. Psalm 138:2 says,

“I will worship toward thy holy temple, and praise thy name for thy lovingkindness and for thy truth: for **thou hast magnified thy word above all thy name.**”

2 Thessalonians 3:1 says,

“Finally, brethren, pray for us, that the word of the Lord may have free course, and **be glorified**, even as it is with you.”

Praise and glory for personal understanding the words of God rightfully belongs to God the Spirit and the words of God (Genesis 41:15-16; Daniel 2:19-23; Luke 24:44-45; 1 Timothy 4:1; Revelation 3:17-22).

2. Men were involved in the translation. Just as Moses, David, Paul, and Jesus Christ were involved in translating, so the translators of the King James Bible were involved to produce under the leadership of the Holy Spirit to produce the greatest book this world has ever seen.

3. The word is eternal. **“Then Simon Peter answered him, Lord, to whom shall we go? thou hast the words of eternal life,”** (Jn. 6:68).

4. The word is flawless; however, it may not match the original. Nobody has yet proved conclusively any errors in the King James Bible.

5. The translation is better than the original. Of course the King James Bible is better than the originals.

- i. You do not have the originals so they can do you no good.
- ii. If you had the originals they would be very impractical for less than 1% of the world’s population speaks Hebrew and or Greek.
- iii. No king in Greece sat on any throne at the time of the writing of the Greek New Testament.
- iv. No book as sold more copies than the King James Bible.
- v. The English language is the international language, not Hebrew or Greek.
- vi. The fruit produced in the Philadelphian Period of Church History far surpasses the church period of the first century when Greek was the popular language because the Bible speaks of the Ephesians that **“left [their] first love,”** (Rev. 2:4).

## Conclusion

Therefore, this matter concerning a Bible translation, it is the King James Bible that is above all other translations that meets all the Biblical requirements for a translation to be accepted, approved of, ‘signed,’ “sealed” and delivered by God, and the basis by which all other translations are to be judged, corrected or even translated, to which all other translations should submit, and unto which all translations around the world ought to strive for. That would produce *infinite* times more unity in the body of Christ than all the Hebrew and Greek knowledge could *ever* produce since 1611.

Just as Jesus Christ is the **“great high priest”** (Heb. 4:14), so He has made us **“priests”** (Rev. 1:6; 5:10) but we are only his undeserving servants and poor servants at that. Since Jesus Christ is **“holy, harmless, undefiled, separate from sinners, and made higher than the heavens;”** (Heb. 7:26) so there can be only one true absolute authority that is higher (Psa. 138:2) that must be holy, harmless, undefiled, separate from sinners, and made higher than the heavens for God Himself placed His very words higher than HIS VERY NAME.

For there is only One **“KING OF KINGS, AND LORD OF LORDS,”** (Rev. 19:16) the Lord Jesus Christ to whom all are to be His subjects and there is only One Book that is His representative in written form on this earth by which everybody is to be subject – the KING JAMES Bible. For that to happen in other languages, just as a decree went out from a King as we have seen, then all of the King’s subjects are to have a translation of the King’s words in their own language. And since the King, the Lord Jesus Christ waited for the perfect language English, the seventh (number of perfection), major language of the world, so would His words be known around the world. The **“Word”** is Jesus Christ (Jn. 1:1, 14, etc.) The **“word”** of God is the AV 1611. It is the very words of

God Almighty. Just as a sinner can trust Jesus Christ to save his soul and to keep that soul from going to hell (Eternal Security) “**sealed unto the day of redemption**” (Eph. 4:30), so also God’s Book, the King James Bible is “**sealed,**” “**kept**” and “**preserved**” (Psa. 12:6, 7).

God ‘**IS,**’ not, ‘was’ or ‘will be.’ He **IS!** He said “**I AM!**” (Exod. 3:14). Therefore He must have an “**IS**” representative in written form on this earth that **IS** (not ‘was’) TRUE TO HIS PERSON, for “God **IS** (notice the italics) our refuge and strength, **A VERY PRESENT HELP IN TROUBLE,**” (Psa.46:1). So since God ‘**IS...**’ therefore all of His *very words* “**ARE**” – for,

“**All scripture IS** (notice the *italics*) given by **inspiration of God,** and **IS** (notice the advanced revelation in *italics* that the ‘originals’ don’t have here) **profitable for doctrine,** for reproof, for correction, for instruction in righteousness:” (2 Tim. 3:16).

So since God “**IS,**” IT IS IMPOSSIBLE FOR HIM TO LOSE ANY OF HIS WORDS for HIS WORDS “**ARE**” AS HIS VERY NATURE “**IS**” in keeping EVERYTHING (Col. 1:17) and “**EVERY WORD**” intact just exactly as The “**I AM THAT I AM:**” would have it!

So we conclude this work with the observation that if any other would embark on translating the Bible into a foreign tongue it ought to be based upon the method laid out in the King James Bible that speaks of a *decree of a king*. It was King Jesus Himself that raised up King James that the Lord would sanction his word (Rev. 3:8, 10). God used King James who would sanction and give the “**authority**” (Esth. 9:29) to the translators so that the common folk would have a book of authority, speak, preach and teach, act, live and die with an authoritative book. That book is – “**quick, and powerful, and sharper than any twoedged sword, piercing even to the dividing asunder of soul and spirit, and of the joints and marrow, and is a discerner of the thoughts and intents of the heart.**” (Heb. 4:12).

For any other translation, that is, in a foreign that is associated with the King’s Book will come out at the *Judgment Seat of Christ* (1 Cor. 3:11-15) much better than something that was not associated with the King’s decree –

“**Where the word of a king is, there is power: and who may say unto him, What doest thou?**” (Eccl. 8:4).

For only that which is pure, like pure “**gold,**” and pure “**silver**” (1 Cor. 3:12) can withstand “**fire**” for –

“Every man’s work shall be made manifest: for the day shall declare it, because it shall be **revealed by FIRE;** and the **FIRE** shall try every man’s work of **what sort it is.**” (1 Cor. 3:13).

“The words of the LORD *are* **PURE** words: *as silver tried in a furnace of earth,* **PURIFIED SEVEN TIMES.**” (Psa. 12:6)

May the KING’S INTERNATIONAL DECREE, THE KING JAMES BIBLE be glorified, translated into other languages for His glory.

“Finally, brethren, pray for us, THAT THE WORD OF THE LORD MAY HAVE *FREE COURSE,* **AND BE GLORIFIED,** even as *it is* with you:” (2 Thess. 3:1).

“I will worship toward thy holy temple, and praise thy name for thy lovingkindness and for **thy truth:** for thou hast **MAGNIFIED THY WORD ABOVE ALL THY NAME.**” (Psa. 138:2)
